PGIN's strategy: To save jobs in the tourism sector

• **No lay off of employees, no closing of businesses, says INTO**

To further cushion the impact of work displacement in the province amid the COVID-19 pandemic, the Provincial Government of Ilocos Norte (PGIN), through the Ilocos Norte Tourism Office (INTO), has continued to extend livelihood assistance to both economically affected employers and employees in the tourism industry.

The INTO had redesigned its Summer Tourism Employment Program into the Tourism Livelihood Continuity Program (TLCP) to aid daily wage earners, informal workers, and freelancers in the gig industry affected by the pandemic

economic crisis.

"If we can recall, we had our 'pay now, work later' scheme last year. This year, we have another strategy where we will support the employees of private tourism establishments.

DA Ilocos Region recognizes winners for the Kabataang Agribiz Challenge

72 out of the 109 aspiring young entrepreneurs were awarded today during the Young Farmers Challenge Provincial Level Awarding with 26 youth beneficiaries from the province of Pangasinan, seven from La Union, 26 and 13 from Ilocos Sur and Ilocos Norte, respectively.

The declared provincial winners will receive P50,000 cash per youth awardee and all are qualified as contenders for the regional search on November 15-19.

Info drive needed to assure parents of vaccine safety

The National Government, together with the eight participating hospitals in the National Capital Region (NCR), has commenced the pilot run of pediatric vaccination of 12 to 17 year old children with comorbidities.

Pfizer and Moderna are primarily the vaccines to be inoculated having earlier obtained the Food and Drug Administration (FDA)'s Emergency Use Authorization.

The DOH estimates that there are around 1.2 million children with comorbidities from ages 12 to 17 in the country. Children with the following comorbidities are eligible for vaccination: 1) medical complexity (i.e. those with long term dependence on technical support); 2) genetic conditions; 3) neurologic conditions; 4) metabolic/endocrine diseases; 5) cardiovascular diseases; 6) obesity; 7) HIV infection; 8) tuberculosis; 9) chronic respiratory diseases; 10) renal disorders; 11) hepatobiliary diseases; and 12) immunocompromised due to disease or treatment.

As vaccination roll-out for teenagers aged 12 to 17 with comorbidities starts, it is imperative that the government should intensify information campaign on its vaccination program in order to assure parents that the vaccines are safe.

The need to conduct information drive is to thwart any reservations and hesitancy from their parents and guardians brought about still by the Dengvaxia incident concerning the anti-dengue vaccine years back.

Since the beginning of the pandemic, the lockdown and the restrictions continued to retard the social growth of the kids. For almost two years now, they have not gone to school (face to face) where they are supposed to socialize with their fellow classmates and teachers. Similarly, they have not been getting the physical activities that the growing children should enjoy.

The lockdowns (proven effective, health protocol-wise) had caused unwanted boredom and mental woes to the weakest.

Indeed, getting eligible children vaccinated against the virus, will surely create a better environment where the kids can literally spread their wings anew with strong confidence knowing well that the jab is their protection from the COVID-19.(IS/DOH)

Nowadays, some renewal communities like the Couples for Christ and Lord's Flock have been sending their lay members to foreign countries where Christ is not yet, or little, known.

Today is **WORLD MISSION SUNDAY**. Before ascending to heaven, Jesus Christ said: "Go out into the whole world and proclaim the Good News to every nation. He who believes and is baptized

Ressa's Nobel award: Row instead of celebration

Tony is a retired section editor of the Manila Bulletin where he worked for 35 years. He was former five-time president of the National Press Club of the Philippines and former president of the Confederation of ASEAN Journalists. He and his wife Elizabeth immigrated to the US in 2009 and now live with their son Percy and his family in Belleville, Michigan. He hails from Piddig, Ilocos Norte.

The awarding of the Nobel Peace Prize to Rappler founder Maria Ressa should be one good reason for a celebration by Filipinos as it was the first time such a global honor was given to a Filipina. But instead, it has become the cause of a controversy.

We believe that the award is as important as the first gold medal Hidilyn Diaz has won for the Philippines in the recent Tokyo Olympics. But while Diaz drew praises from people all over the country for her feat, Ressa generated criticisms for her singular honor of winning the Nobel Peace Prize.

And even praises given to the founder of the

news website Rappler were taken with a grain of salt. Ressa herself doubted the sincerity of the praises for her by presidential spokesperson Harry Roque.

Reacting to Roque's statement congratulating her, Ressa said, "Thanks, but no thanks." "I suppose thank you, and then what I didn't appreciate is almost hand in hand it came with a hit," Ressa said.

"Hand in hand with that [praise] was this reminder, which is a lie... that the cyberlibel complaint

Reading: a useful yet seemingly neglected skill

Reading is one of the significant language skills that we all need in order to survive the rigors of academic life and professional advancement. It is one of the indicators of literacy and one of the most palpable ones, too. Without developing reading, we would not be able to live purposefully simply because we cannot articulate what we want to express.

We regard reading not only as a survival tool but also as a means to an end. Whether others think of us as career-driven hypocrites, it is none of their concern because they are not the ones who feed us. Because we are still in a state of pandemic, we

have all been forced to read, something that we have not done religiously before.

For us teachers, we need to read in order to gain professional competence and, ultimately, promotions. It is ironic, though, that we teachers sometimes (no, most of the time) detest reading due to a plethora of materials that we need to digest.

In developing our reading skills, to be able to read at a basic level while young and emergent is good; to comprehend and interpret are better. To be able to critique ideas and to create something to

BBM: MSMEs key to economic recovery

Allowing micro, small and medium enterprises (MSMEs) to operate again will help the country's economy to bounce back amid the pandemic crisis, according to presidential aspirant Ferdinand "Bongbong" Marcos Jr.

The Partido Federal ng Pilipinas (PFP) standard-bearer said to achieve this goal, vaccinated workers and even business establishments that were closed down due to quarantine restrictions brought by the COVID-19 must be allowed to go back and continue their operations again.

"Let's allow the small businesses to operate again because the economy will not move if there is no economic activity. There

must be someone who will buy and avail services because it has a multiplier effect that can help in the recovery of the economy," he added.

"As long as they are vaccinated, let's allow them to go out and work. Let's give them a privilege since they are already safe," Marcos said.

Almost two years into the pandemic, Marcos said people want jobs for them to support their families and while some are still employed, they are not earning due to the lockdowns and restrictions imposed by the government. He added that some employees are even on a "no work, no pay" basis making it hard for them to sustain their daily

living.

Data from the Philippine Statistics Authority (PSA) showed that 3.76 million Filipinos remained jobless since June 2021. The government said the 7.7 percent unemployment rate shows the limits of job creation due to quarantine restrictions, especially in the National Capital Region (NCR).

"If you look into the lives of Filipinos, they are looking for jobs right now as they need money to



support their families. We need to have an extensive approach so that everyone will benefit," he said.

Marcos believed there is a need for the creation of jobs once the country reaches herd immunity where almost 70 percent are fully vaccinated against the COVID-19.

"The opening of our economy must be well-planned in order for us to return to our normal lives," he said.

executive, lawyer or unemployed. What counts is not geography or place, but the spirit or motive that impels a baptized Christian to follow the mandate of Christ.

Remember St. Therese of the Child Jesus? She never stepped out of the four walls of her Carmelite cloister but was chosen as the universal Patroness of Catholic missions. She merited the title because of her obsession to save immortal souls by offering every little act, like picking up trash, every bodily pain of sickness, and fervent praying.

When I was ordained priest in our missionary congregation, Society of the Divine Word (SVD), I applied to work in Mexico, Central America. Unfortunately I did not get my wish. The farthest I've gone to is Mexico...Pampanga!

That doesn't mean, however, that I am not a genuine missionary. By my work in the media or supporting seminarians under the "Adopt A Seminarian" scholarship program, I am a missionary.

In this connection, let's not be missionaries only on Mission Sunday. As a good Christian, the mission spirit should be a daily, continuing attitude and action like what St. Therese of the Child Jesus did.

Also, you can be missionaries by means of extending financial assistance for the support of missionaries. Money is a necessity in the work of evangelization. Churches, schools, convents, clinics, social centers are needed, especially in far-flung bush mission.

Ask yourself. Am I contributing something for the mission the Lord commanded me to do through the three Ts – Time, Treasure, Talents?

solve problems are the best.

One who is not able to read is bound to be ridiculed by conventional society for being considered bereft of intellect and wisdom. In addition, one who is illiterate tends to be deprived of opportunities, such as job security, financial freedom, lifestyle upgrades, and, ultimately, respect in society. Although there are formerly illiterate people who have succeeded, these people have chosen the path to education, which they initially found challenging yet eventually fulfilling and rewarding.

The palpable problem we have observed among our youth nowadays is that they tend to read less of the physical books and more of the instant, online reading materials. They have the impression that everything they read on the internet is gospel truth but do not know that not all that they read and digest are true.

Whose fault is it?

Do we blame a single entity for the decline of our learners' reading abilities?

Not at all, though some of them must take a majority of the blame!

There are so many factors, such as lack of time, lack of motivation, lack of a clear purpose, and a lack of encouragement from DepEd and CHED (though they are making so much effort now, if we can brand such efforts as laudable and commendable)!

What the results of the PISA 2018 examination reflect are our inadequacies in terms of teaching, practicing, and promoting reading, among other skills such as mathematical literacy and scientific literacy.

Why is reading essential yet neglected?

First, blame it on the rampant use of gadgets. Parents are generally at fault when they fail to read to their children and to read together. Gadgets may

22k Ilocos Sur farmers, fish cage operators get assistance

VIGAN CITY, Oct. 20 (PIA) - - More than 22 thousand farmers and fish cage operators in Ilocos Sur will benefit from various assistance provided by the provincial government in a ceremonial distribution held Tuesday in front of the Provincial Capitol here.

The provincial agriculture office said some 22,286 corn growers will receive free corn seeds through the provincial government's agriculture assistance program dubbed as, "RYAN Corn Seeds Program."

Assorted vegetable seeds will also be distributed to all cities and municipalities of the province.

Moreover, some 240 fish cage operators affected by fish kills from the municipalities of Magsingal, Bantay, Sta. Catalina, and San Vicente will receive cash assistance amounting to P1.06 million.

Charito Ragasa, a corn grower for over 20 years from Caoayan town, expressed his gratitude to the provincial government

for its unending support to farmers in the province.

"Malaking tulong ang mga libheng corn seeds na ito sa amin lalo at sobrang mahal nito umaabot ng mahigit limang-libong piso. Malaki ang matitipid namin at magagamit namin ang perang pambili sana ng mga butil sa pagbili ng iba pang input para mas maging masagana ang aming mga ani," he said.

Ragasa added that the various assistance they receive from the provincial government, both during corn and rice cropping season, has been very helpful for their family as farming is their main source of income.

With the severe damage of storm 'Maring' especially in the agriculture sector and the challenges brought about by the Covid-19 pandemic, Governor Ryan Luis V. Singson assured that the provincial government will continue and intensify its agriculture assistance program to aid farmers' needs, hence, maintain the food supply of the province. *(Joyah Mae Quimoyog/PIA Ilocos Sur)*

Ilocos Sur residents receive DOLE livelihood assistance

VIGAN CITY, Oct. 20 (PIA) - - Residents of the province of Ilocos Sur received various livelihood assistance programs from the Department of Labor and Employment (DOLE), recently.

Jipolito Palo, barangay chairperson of San Julian Norte in this city, expressed his gratitude to the national government for the assistance they received from the DOLE.

Said barangay was one of the barangay-recipients awarded with 10 bike packages in a caravan held on October 16 led by Labor Secretary Silvestre Bello III.

The bike package also included accessories such as helmet insulated bag, reflectorized vest, and raincoat, and mobile phones with a load worth five thousand pesos.

Palo said the bikes will be placed in their barangay

hall, which will be used by barangay officials during their patrolling, and other house-to-house delivery of various services in the barangay.

"Nagpapasalamat kami sa DOLE at malaking tulong ang mga ito sa pagroronda namin. Makakatipid din kami sa paggamit ng gasolina sa sasakyan ng barangay at makapag-exercise pa kami," he said.

With the challenges brought about by the Covid-19 pandemic, Palo added that these may also be used to improve livelihood for residents who sell goods or vegetable/fruit harvests in the barangay.

A total of 250 residents of the province have received bike packages under the DOLE's Free Bisikleta (FreeBis) Project (amounting to five million pesos).

La Union continues efforts to aid typhoon-affected residents

SAN FERNANDO CITY, Oct. 20 (PIA) -- After the onslaught brought about by severe tropical storm "Maring", the Provincial Government of La Union continues its recovery efforts to aid heavily-affected residents.

Adamor Dagang, provincial information officer, said relief operations are underway after Typhoong Maring hit the province last week.

"To date, around 25,000 food packs have been immediately distributed to typhoon victims," Dagang said.

He also said that relief items distribution continues until the evening, as La Union Governor Francisco Emmanuel R. Ortega directed that assistance be

provided to the affected provincemates as soon as possible.

In particular, Dagang informed that the most-hit towns in the province are those located in the first congressional district namely Bangar, Luna, Balaoan, and Sudipen.

However, areas in San Juan, San Gabriel, Bacnotan, and Santol are also reported to have been affected.

Dagang further stated that the province is open to accepting donations from all benefactors, including national figures, government agencies, and private businesses.

He also expressed gratitude to the other local government units in La Union, which were

La Union cemeteries will close on Undas season

SAN FERNANDO CITY, Oct. 21 (PIA) -The Provincial Government of La Union orders closure of all the cemeteries in the province, both public and private, from Oct. 29 to Nov. 4, 2021.

Governor Francisco Emmanuel R. Ortega III signed Executive Order No. 51 series of 2021 on Monday to establish rules and regulations in view of the upcoming traditional observance of the Undas week.

This is to ensure adherence to the safety protocols during this time of community quarantine hence, prevent further transmission of the deadly virus.

Ortega mandated all the local government units to close all cemeteries, as well as memorial parks, columbaries, and other similar places on said dates.

"Physical visits to graves of departed loved ones is allowed from Oct. 26 to Oct. 28 and Nov. 5 onwards subject to the rules set for the observance," Ortega stated.

Number of visitors in all cemeteries, memorial parks, and other similar establishments must only be limited to 30 percent of the venue's capacity.

Mass gatherings must be strictly prohibited.

Pangasinan gov't opens walk-in vaccination site

L I N G A Y E N , Pangasinan, Oct. 19 (PIA) - Pangasinenses can now walk in and get their first dose of coronavirus disease 2019 (COVID-19) vaccine as the Provincial Government of Pangasinan has opened the vaccination center at the Pangasinan Training and Development Center II in this town.

Dr. Anna Ma. Teresa De Guzman, provincial health officer of Pangasinan, said the provincial government has opened the vaccination center for those who are 18 years old and above (no more priority population group) in order to cover a larger populace.

"We are open now, those who are 18 years old and above are encouraged to go to the vaccination center," De Guzman said.

She said as of October 17, PHO has already inoculated at least 857,439 with first dose and second dose of the Covid-19 vaccine, or 43.4

percent of the total eligible population of 1.98 million in the province.

She added out of the number 23.4 received their first dose of the vaccine while 20 percent including those vaccinated with Janssen vaccine are now fully vaccinated.

"We have an increase of like 30 to 40 percent of allocation of vaccine sa atin sa province and we are appealing to the local government units that once they received their allocation of vaccine sana within the week ay maibigay po natin," De Guzman said.

She also encouraged all LGUs to organize another team that will go to far-flung areas to conduct vaccination to increase the accessibility of the vaccine and reach the persons with disabilities (PWDs) and bed-ridden senior citizens in their areas.

is filed by an individual and what the government repeatedly refuses to say is that it takes a government to actually file a criminal case. So this is the government's case, it's the Department of Justice's, it is their decision. So they should really own it. So thanks, but no thanks."

Ressa has been fighting multiple legal challenges in courts related to Rappler's investigative reporting of President Duterte's government, its bloody war on drugs and its use of social media to target opponents.

"It is a victory for a Filipina, and we are very happy for that," Roque told reporters, responding to a question on what the award meant for the government.

"Of course, it is true there are individuals who feel Maria Ressa still has to clear her name before the courts," he said. He has described Rappler, launched in 2012, as a "fake news outlet" and a tool of the US Central Intelligence Agency, claims which Ressa has dismissed as nonsense.

Ressa also disputed Malacañang's claim there was no censorship of media in the country.

"Hindi mo na kailangan sabihin. Tingnan mo nalang ang mga nangyayari (You don't have to say it. You just look around)," she said. "Nasa'n kaya ang franchise ng (Where is the franchise of) ABS-CBN? The last time that the ABS-CBN lost its franchise was when a dictator declared a martial law and shut down the network."

It has been more than a year since 70 members of the House

Representatives' Committee on Legislative Franchises, a panel dominated by administration allies, voted to reject ABS-CBN's bid for a new franchise.

The network was first shut down in 1972 when Marcos imposed martial rule.

Nearly five decades later, it was forced off the air under the Duterte administration. National Artist F. Sionil Jose has a contrary take on the state of press freedom in the Philippines.

Sionil wrote, "I have criticized Duterte but not on press freedom. The Philippine press is alive and well not because of Maria Ressa. No writer is in jail. There is no censorship. Duterte hasn't closed a single newspaper or radio station."

The closure of ABS-CBN was made by Congress which did not renew the ABS-CBN franchise. Sure, he has influenced Congress but the real issue against ABS-CBN, as I have pointed out, is not press freedom but money, politics, power and its abuse by the Lopezes who own the TV network. Sure, journalists have been killed in the Duterte regime but just as it were in the past administrations; but those killings cannot be laid at Duterte's door. Usually, they are made by minor politicians or officials attacked by journalists. The real test for journalists was made during the Marcos dictatorship when he imposed censorship, closed all media and jailed journalists."

Who is Maria Ressa? Born in the Philippines,

Ressa grew up in the US and returned to the country in the 1980s only after the fall of authoritarian leader Ferdinand Marcos.

A former CNN journalist, she founded Rappler in 2012. It is one of the few local sites to openly criticize the Duterte administration and its brutal war on drugs, which has claimed thousands of lives.

Rappler is one of the country's most popular news sites, in part because of its focus on a younger audience and embracing social media.

In June 2020, Ressa was convicted of cyber libel together with Rappler reporter Reynaldo Santos, Jr. in connection with a news story about a businessman, Wilfredo Keng, who claimed the story was libelous because it linked him to human trafficking and drug smuggling.

Lawyers for Keng insisted that the case was about clearing the name of their client, after Rappler's allegations, citing an "intelligence report" that Mr Keng was involved in human trafficking and drug smuggling. He has always denied the allegations.

In convicting Ressa and the reporter, Judge Rainelda Montesa said Rappler had failed to present the report to the court and hadn't verified the claims allegedly contained in it.

The judge likewise said Rappler offered no proof to back up its allegations against Keng and that her verdict was based on evidence presented to the court, adding that freedom of the press "cannot be used as a shield" against libel.

Filipino journalists familiar with the case also noted Rappler's failure to publish the side of Keng. Keng sent to Rappler a statement denying the allegations but Rappler did not publish it. For the sake of fair reporting, newspapers or news websites are obliged to air the sides of parties involved in cases or controversies. This is required by the Journalists' Code of Ethics.

Had Rappler published the statement, the court would have taken it at least as a mitigating element.

I don't personally know Ressa even though I had been a journalist in the Philippines for 30 years. I did not have the opportunity to meet her, but I noticed that she is a fighter and a committed journalist.

I'm sure her Nobel Peace Prize with a monetary reward of \$1.1 million will surely inspire her to ramp up her crusade against the enemies of press freedom.

She urged her fellow journalists to be also committed to their profession.

She said that the 2022 election is going to be "a battle of lies," but added this is the best time to be a journalist. "What a journalist does is to speak, to ask questions, to analyze, to demand answers. It's not for yourself, it's really for the people so that we hold the government and the private sector accountable. Nasa Konstitusyon po 'yan natin (It's in our Constitution), and the power of journalist is the power of the people," she said.

So be it.

Batac university to open BS Psychology next year

LAOAG CITY, Oct 21 (PIA) – The state-run Mariano Marcos State University (MMSU) in Batac City, Ilocos Norte will be offering Bachelor of Science in Psychology next school year.

This soon-to-open undergraduate course is made possible through the approval of the University Board of Regents (BOR) during their regular meeting on October 14.

Through this program, the province will be able to produce registered psychometricians or psychologists as they pass various board examinations and trainings.

According to Prof. Christine Joy Lim, program-in-charge and faculty member of the College of Arts and Sciences-Department of Social Sciences, this move will open opportunities for psychology professionals and address more mental health services as guided by the Republic Act 11036 or the Mental Health Law.

"As our province is also developing economically with the influx of multi-national companies investing here, the need to outsource workforces can be minimized by supplying more BS Psychology graduates from MMSU," said Lim.

BS Psychology can also be considered as a pre-medicine course and for pre-law and business management courses. The university adds that graduates of this program may also take on the following specializations:

Future students must complete 141 units which include 36 units of general education courses, 8 units of basic courses, 45 units of required courses, 12 units of psychology elective courses, 20 units of natural sciences electives, 8 units of physical education, 6 units of national service training program, and 6 units of enhancement courses.

MMSU President Dr. Shirley Agrupis said the university is presently working on the development of the laboratory and completion of library resources at CAS for conducive learning for incoming students in this course.

"Competent and high-caliber professors of the program will surely develop industry-ready graduates, thereby contributing to national development," said Agrupis. (Ma. Joreina Therese Blanco/PIA Ilocos Norte)

DOST 1 welcomes new S & T undergraduate qualifiers

The Department of Science and Technology – Region I thru its Scholarship Unit conducted a series of virtual orientations for the 2021 S&T Undergraduate Scholarship Qualifiers from Region 1 last September 23-24, 2021. A total of 229 undergraduate qualifiers from the different provinces in the region attended the said activity together with their parents and legal guardians via zoom platform. DOST 1 provincial staff, scholarship coordinators from SUCs and private HEIs as well as officers of the different scholarship associations in the region are also present. This year’s orientation featured discussions on the provisions of the Scholarship Agreement, S&T Scholarship policies, procedures and an open forum. This is done prior to the signing of their Scholarship Agreement.

The S&T Undergraduate Scholarship is one of the scholarship programs

being offered by the DOST-SEI, specifically for senior high schools who will pursue S&T related courses in college. This program aims to stimulate and entice talented Filipino youths to pursue lifetime productive careers in science and technology and ensure a steady, adequate supply of qualified S&T human resources which can steer the country towards national progress. It has 2 component programs: a) Republic Act (RA) 7687 program, which meant for socioeconomically challenged students; and b) Merit program, which is awarded to students with high aptitude in science and mathematics.

During the orientation, Ms. Adelisa C. Florendo, Technical Scholarship Coordinator of DOST I emphasize that in order to avail the scholarship award, qualifiers must enroll in a Priority S&T course in State Universities and Colleges (SUCs), or in private higher education institutions recognized by the Commission on Higher

Education as Centers of Excellence or Centers of Development or with Level III accreditation from the Federation of Accrediting Agencies of the Philippines.

For those qualifiers who will avail and signed the scholarship agreement will enjoy full benefits of the scholarship for the whole duration of their S&T program. These include monthly stipend of ₱7,000; a tuition fee subsidy of up to ₱40,000 per academic year for those who will enroll in private institutions; annual book allowance of ₱10,000; one-time MS/PE clothing allowance amounting to ₱1,000; one economy-class roundtrip fare per year for those studying outside their home province; group health and accident insurance, and ₱10,000 for thesis allowance.

“The benefits that you will receive are designed to boost your studies, it is an investment made by our Filipino people to help you reach not just your dreams but the good that

comes with you reaching your goals”, said DOST Secretary Fortunato T. de la Peña on his message.

Aside from the financial benefits, DOST scholars will also have the opportunity to join different scholarship activities being conducted by the DOST-SEI and DOST I that will surely help them to become more responsible, competent, goal-oriented and patriotic Filipinos.

“Be serious with your academics but live a balanced life. Do socialize and start practicing how to serve people and the country. You will realize that you are gifted with talent and intelligence and there is purpose in that. You will lead and serve”, de la Peña said.

DOST-SEI scholars are required to render service in the country, preferably along their fields of specialization, after graduation for a period equivalent to the number of years they enjoyed the scholarship. (Jayce Andres, Scholarship Staff)

Agri-fishery sector in R1 suffers P1.5B loss due to TS Maring; DA to assist affected farmers

LA UNION - The Department of Agriculture is set to release P50 million under the Quick Response Fund (QRF) to rehabilitate areas in Ilocos region devastated by TS Maring.

This is apart from the P80.8M worth of buffer stock from the DA Ilocos region ready to be distributed to typhoon-affected farmers.

Said amount covers the provision of hybrid and certified rice seeds, corn seeds, fertilizers, and livestock livelihood assistance (chicken, goat and cattle), drugs and biologics, plus feeds.

As of writing, the total estimated damages in the agriculture and fishery sector climbed to P1.516 billion with crops recording the highest losses of 63,430

MT amounting to P1.164 billion due to intense rain and flooding. Palay incurred the highest loss share of 96.55%.

For the livestock sector, initial damage was recorded at P76.9 million, P133.8 million for the fisheries sector, and P140.6 million in infrastructure (irrigation systems).

DA-RFO I team consist of Field Operations Division and PMED staffs, in coordination with the Regional Disaster Risk Reduction and Management Council (RDRRMC) are conducting Rapid Damage Assessment and Needs Analysis (RDANA) activity to further assess actual damages on field and be able to provide appropriate interventions.
