IN Gov. MMM wins re-election bid

 Team Marcos dominates the province's key elective posts

Incumbent Ilocos Norte Governor Matthew Marcos Manotoc won his re-election bid by landslide votes in the local polls held on May 9, 2022. He will serve his second term in the next three years.

The COMELEC through the provincial board of canvassers has formally proclaimed Governor Manotoc as the official winner during a simple ceremony held on May 10 at the SP session hall, Provincial Capitol, Laoag City.

The Governor garnered

261,885 votes, while his rival, former Congressman Rodolfo C. Fariñas got 94,372 votes.

The Governor thanked his province mates for reelecting him saying "it's truly an honor and a pleasure to work here in Ilocos Norte as your Governor."

DOH opens five negative pressure isolation rooms at MMMHMC

BATAC CITY, Ilocos Norte - Department of Health (DOH) Undersecretary Elmer G. Punzalan and Regional Director Paula Paz M. Sydiongco led the blessing and inauguration of new five negative pressure isolation rooms located at the Mariano Marcos Memorial Hospital and Medical Center (MMMHMC) in Batac City, Ilocos Norte on May 11, 2022.

"In these critical times brought about by the Covid-19 pandemic, every health facility must have a properly working ventilation systems because of airborne infections that might expose patients such as immune-compromised, newborns, the elderly including hospital personnel as well as visitors can also be at risk of contracting airborne diseases as well, thus the need for a separate isolation rooms for the purpose," Director Sydiongco stated.

"With these in place, any airborne particle that originates in the room will be filtered and this traps and keeps potentially harmful particles including viruses, bacteria, fungi, yeasts, molds, pollens, gases, VOC's (volatile organic compounds), small particles and chemicals and other pathogens within the constraints of the room."

The blessing of the new isolation rooms was officiated by Rev. Father Lloyd Vincent Sungat of the Immaculate Conception Parish of Batac.

The five isolation rooms were funded by the World Bank as part of its Covid-19 emergency health support program by strengthening developing country responses from infectious diseases.

Newly elected officials, asked to prioritize public welfare

President Rodrigo Roa Duterte has called on the new set of elected officials to earnestly serve the Filipino people and prioritize public welfare above everything.

In his Talk to the People aired Thursday morning, President Duterte congratulated in advance those who will be victorious in the 2022 elections and also thanked the losing candidates.

"I am hopeful that you will serve the Filipino people with all your heart and ability, and prioritize the welfare of the general public above everything," the President said.

And to the losing candidates, he thanked them for their participation in the electoral process, hoping that although they weren't lucky, they will continue "to serve our people in your capacity as leaders in your respective sectors and communities".

Congratulating the Filipino people, he said: "You made the elections successful because you have made your will known by performing your sacred right and duty to vote."

President Duterte likewise lauded the efforts of the Commission on Elections (Comelec), soldiers, policemen, poll workers, and volunteers in ensuring the peaceful conduct of the elections.

At the same time, he encouraged the Filipino public to continue supporting the Comelec and its civil society partners so that the poll body could do its work correctly and proclaim the winners.

The President expressed hope that the Comelec would find time to investigate the reported election glitches to ensure the sanctity of the ballot.

The chief executive also called on Filipinos to unite as he concludes his term.

"By noon of June 30, I invite the public to join me in running behind our new elected leaders so we can continue the difficult but rewarding task of building a stronger and more progressive nation," he said. PND

Fr. Joseph Dau Vu, SVD, was a Catholic chaplain of the Vietnamese "boat people:" refugees in Morong, Bataan. He related to me how he together with 55 compatriots slipped out of communist Saigon on an old, decrepit motorized boat and sailed to freedom.

The "boat priest" reminisced with a tinge of sadness, "When fishermen from neighboring countries saw us, they attacked, robbed and exploited us. But when Filipino fishermen saw us, they gave food and welcomed us. Why are Filipinos different?" Fr. Dau Vu asked and answered: "It is because Filipinos are Christians."

That Vienamese priest's comment is very heartening, a tribute to Filipinos for their compassion and hospitality. Indeed, Christianity that's truly lived should make one

more loving, more kind, more compassionate.

To love as Christ loves is his explicit teaching in this 5th Easter Sunday gospel. At the Last Supper, Jesus said. "I give you a new commandment: Love one another. By this, everyone will know that you are my disciples" (Jn 13,34).

What's this "new love" Jesus refers to? There are numerous kinds of love. Well known are the romantic, sexual, warm affection of married couples, parental love and others. What Jesus means is the selfless love of one person for another without sexual implications. This is close to the sacrificial love of a mother.

and Employment (DOLE) Regional Director Atty. Evelyn Ramos, who is also RTWPB1 chair, said this wage increase is a result of comprehensive deliberation of the wage board.

"We took into consideration all concerns and manifestations which arose during our public consultations and hearings. one thing was clear: both management and labor sectors were amenable for an increase," RD Ramos said.

RTWPB1

Department of Labor approved the Wage Order No. RB1-DW-03, which provides for a minimum wage of ₱5,000.00 for kasambahays.

> The new daily minimum wage rate (DMWR) sees substantial hike from the previous years. In 2019, RTWPB1 issued RB1-20 which provided for P340 DMWR non-agricultural establishments with more than 30 employees; P310 for 10-29 employees; and P282 for 1-9 employees. agricultural employers, **DMWR** was at P282 for nonplantation, and P295 for

plantation.

An increase be gleaned for kasambahays, from previous P4,500 Cities and First-Class Municipalities and P3,500 for other municipalities.

"This time, the wage board thought it proper to set the monthly minimum wage rate of P5,000 for kasambahays regardless of area classifications," RD Ramos said.

The increased rates, moreover, are above the region's poverty the Wage threshold, Board chair emphasized.

The minimum wage

process determination is pursuant to Republic Act 6727 or the Wage Rationalization Act and NWPC Guidelines No. 03, series of 2020 or the Omnibus Rules Minimum Wage Determination.

The said approved wage orders shall be transmitted to the National Wages and Productivity Commission, for "Once affirmation. affirmed, the orders shall be published in local newspapers and it will be effective in 15 days," RD Ramos conveyed. (By Justin Paul D. Marbella)

8 Ortega leaders win political posts in La Union

SAN CITY, May 12 (PIA) -Eight out of nine Ortegas who bid political posts in La Union province won in their respective races on the May 9 National and Local Elections.

The Ortega political clan which is believed to be the Philippines' political family with the longest unbroken political rule, reigning over the province for over a century as of 2013, continuously work together to retain their hold and desire to serve.

Raphaelle Veronica "Rafy" Ortega-David, daughter of outgoing Governor Francisco Emmanuel "Pacoy" Ortega III, was proclaimed as the newly-elected governor who bagged 348,269 votes compared to her opponent who gained 39,907 votes.

Pablo Ortega's younger brother, Mario Eduardo Ortega proclaimed as vicegovernor of the province as he was unopposed.

His son, Paolo Ortega with 144,295 votes won against Migz Magsaysay having 36,330 votes and Mario Rodriguez

FERNANDO with 7,247 votes representative of the first congressional district of La Union.

> Further, Geraldine Joy Ortega, who is a political newcomer, ranked number two as provincial board member with 119,648 votes.

> The outgoing governor's brother, Alfredo Pablo "Alf" Ortega was re-elected as vice mayor of San Fernando City having 36,656 votes while unopposed Emmanuel Victor Ortega won the same position in San Juan town.

> Mariquita Further, Ortega, wife of Pablo, also ranked first among the elected councilors in San Juan town.

> After his proclamation, Alf acknowledged his supporters.

Marcos, Duterte get majority of votes in La Union

FERNANDO SAN CITY(PIA) -- The Marcos-Duterte tandem received the majority of votes from the electorate in La Union after the national and local elections on May 9, 2022.

Ferdinand "Bongbong" Marcos Jr., received solid support 425,792 votes. with His top contender presidential race, incumbent Vice President Leni Robredo, came in second with 24,566 votes.

presumptive Also, president vice Sara Duterte won the hearts of the majority of the voting public with 379,714 votes. She was considerably ahead of the next vice candidate, presidential Vicente Sotto with 45,276 votes.

Both Marcos and Duterte wooed the voters in La Union when they visited last February 25 and February 18, respectively. They also got an official endorsement from the Ortega political clan ahead of the voting period.

Meanwhile, topping the list of senatorial bets of the voters is Robin Padilla who garnered 244,902 votes.

DENR tells candidates to dispose of campaign materials properly

Department Environment and Natural Resources (DENR) Acting Secretary Jim O. Sampulna urged the candidates in the 2022 national and local elections to clean up and dispose of campaign sure that the existing materials in accordance with Republic Act (RA) 9003 or the Ecological Solid Waste Management Act of 2000.

"Win or lose, these candidates must consider the long-term consequences of their campaign materials in the environment. Therefore, must encourage their supporters and volunteers to take down these materials, especially those made of plastic, and dispose these properly," Sampulna said.

He added that the DENR, together with the local government units (LGUs), will be "at the beck and call" of the Commission on Elections

of (Comelec) to make sure the Interior and Local materials; imposing the that a resolution will crafted requiring candidates to remove election materials after every campaign period.

"We will make environmental laws, such as RA 9003, will strengthen the resolution," Sampulna said.

Moreover, DENR chief asked the candidates to assemble their teams to "clean up voluntarily instead of being intimidated by possible violations after the election season."

"Candidates could show how sincere they are in serving the country this way," he added.
