The peace covenant is aimed at encouraging various stakeholders such as the

Armed Forces of the Philippines, Philippine National Police, local government units, indigenous cultural communities, government agencies, and public and private sectors to level-off understanding on the healing, reconciliation and operationalizing the 11 building blocks in the ancestral domain in support of the whole of nation

approach by empowering former rebels, IP youth, and leaders.

Provided in the Indigenous Peoples Rights Act (IPRA), the 11 building blocks are 1) confirmation of indigenous political structure (IPS); 2) registration and accreditation of Indigenous

August Inflation eases to 6.3 Percent

Headline inflation eased to 6.3 percent year-on-year in August from 6.4 percent in the previous month. This was within the BSP's forecast range of 5.9-6.7 percent for August. The resulting year-to-date average inflation of 4.9 percent is above the Government's average inflation target range of 2.0-4.0 percent for the year. By contrast, core inflation, which excludes selected volatile food and energy items to depict underlying demand-side price pressures, climbed to 4.6 percent in August from 3.9 percent in the previous month. On a monthon-month seasonally adjusted basis, inflation slowed down to 0.4 percent in August from 0.6 percent in July.

The moderation in headline inflation was traced to slower increases in the prices of heavily-weighted food items, such as meat and fish. Year-on-year vegetables inflation also fell to negative territory in August due in part to base effects from the substantial price increase a year ago. At the same time, transport inflation decelerated given the decline in domestic petroleum prices.

Meanwhile, the rise in core inflation reflects the faster price increases of core goods, namely, sugar as well as oils and fats, both of which have reached double-digit inflation rates. Housing (rent), education, and passenger transport services inflation rates have also gone up, further contributing to the increase.

The latest inflation reading is consistent with the BSP's view that inflation could remain elevated over the near term due to persistent and broadening price pressures. For this reason, the BSP reiterates the importance of urgent non-monetary government interventions to primarily ease domestic supply constraints. Looking ahead, the BSP is closely monitoring all risks to the future inflation path and is prepared to take necessary follow-through action to safeguard price stability. (BSP)

BATAC CITY (PIA) President Ferdinand "Bongbong" MaBrcos Jr. flew here from Manila and ioined fellow Ilocanos in the celebration of the 105th birth anniversary of his late father former President Ferdinand Edralin Marcos Sr. on September 11.

Peoples Organizations (IPO); 3) Certificate of Ancestral Domain Title (CADT) and Certificate of Ancestral Land Title (CALT) delineation process; 4) establishment Ancestral Domain Management Office (ADMO); 5) Ancestral Sustainable Domain Development and Protection Plan (ADSDPP) formulation; IP Wealth Management-Community Resource Management Development Plan (CRMDP) formulation; 7) institutionalization of Certificate of Precondition CP), Free, Prior and Informed Consent (FPIC), and Exercise of Priority Rights (EPR); 8) effective Indigenous Peoples Mandatory Representative (IPMR) in the local legislative bodies; 9) efficient and enhanced MOA/MOU/ MOC formulation; 10) socio-economic activities with IP cooperatives; and ancestral domain defense system.

First super health center in Ilocos Region to rise in Pangasinan

The first 'super health mga pasyente na pumunta center' will soon to rise in the province of Pangasinan Senator Christopher Lawrence T. Go and DOH Ilocos Regional Director ay kumpleto na Paula Paz M. Sydiongco led the groundbreaking ceremony of the health facility together with local government officials of the province.

The super health facility will be constructed in Brgy, Esmeralda, with a population of around 33,000, in the town of Balungao in Pangasinan.

Senator Go, who was the guest of honor stated that the center will provide all the basic health needs including specialized health services at the local level.

"Ang health facility pong ito ay mayroon ng out-patient department, laboratory, ultrasound at iba pang mga serbisyong medikal upang hindi na mahirapan ang

pa sa pinakamalapit na ospital at gumastos pa ng pamasahe."

'Dito lang ang ninyong kakailanganin medical services gaya birthing diagnostic, pharmacy at emergency services," he assured.

The establishment of the center was made possible through the efforts of the local government of Balungao, Pangasinan.

The first phase of the super health center will be funded by the DOH's Health Facility Enhancement Program at ₱6.5 million.

Over 400K Pangasinenses receive COVID-19 booster shot

DAGUPAN CITY (PIA) - A total of 408,963Pangasinenses have received their COVID-19 booster shots as September 6, according to the latest report of the Department of Health-Ilocos Center for Health Development 1 (DOH-CHD 1),

Dr. Rheuel Bobis, COVID-19 focal person of DOH-CHD Pangasinan covered 18.31 percent of its target population eligible to receive booster vaccines for COVID-19.

"Kung atin pong titignan 'yung mga province natin na meron pong mataas na booster coverage, nangunguna po dyan ang Ilocos Sur na may 47.83 percent coverage pagdating po sa first booster. Pangalawa po ang Ilocos Norte with 37.83 percent, La Union with 29.95 percent, at panghuli po ang Pangasinan na mayroon lamang pong 18.31 percent na booster coverage," Bobis said.

Bobis clarified that the low percentage of booster coverage in Pangasinan is

due to its target population.

"Kung base sa number, Pangasinan po ang may pinakamaraming booster shot na na-administer. Kaya po mababa lamang percentage, ang malaki po kasi populasyon ng Pangasinan kaya mas marami po tayong dapat habulin at dapat kumbinsihin na magpa-booster shot para ma-achieve po natın yung 50 percent na atin pong coverage pagdating sa booster shot," Bobis explained.

He said under the vaccination PinasLakas program, DOH targets to vaccinate booster shots to at least 90 percent population of senior citizen and 50 percent of the population who both received their second dose of COVID-19 vaccines.

As of the latest monitoring dated September 6, at least 3,793,319 individuals in Region 1 were fully vaccinated. Of the number, some 446, 066 senior citizens or 84.02 percent received their booster
