BAYONG ordinance: Laoag's plan for lesser plastic in the city

Laoag City is turning green with an intensive plan to lessen plastic usage for local businesses in the city through the implementation of its **BAYONG** ordinance in 2023.

The Bring Along Your Own Natural Greenbag or BAYONG ordinance aims to regulate the use of plastic bags and other materials made of plastic as secondary packaging or plastic carry out bags for all forms of merchandise.

The ordinance also seeks to ban the use of styrofoam for food and other packing needs.

This ordinance will be a priority for the Laoag City Environment and Natural Resources Office (CENRO) for 2023, according to their head, Mylene Pascual.

Let's examine the ordinance that is expected to help Laoag City shine in environmental protection.

In this ordinance, individuals and establishments will be prohibited to use thin film, single-use or carry out plastic bags for the merchandise they are purchasing especially for dry goods.

"Reusable eco-bags are perfect to use when shopping for dry goods because it's a lot sturdier and more spacious compared to a regular plastic bag," Pascual suggests.

For those who don't want to spend extra money on an eco-bag, repurposing old bags and other containers can also be a valuable option.

Moreover, food establishments, like carinderias, are also banned from using styrofoam to pack their food and drinks; instead they are to use paper packaging and non-plastic spoons and forks as alternatives.

Buyers, however, are allowed to use plastic bags only when purchasing wet products.

Under the exemption of this ordinance, buyers are limited to use only one plastic bag for all their wet products when purchasing in the city's public market.

Pascual explained, "For wet products lang ang exemption. Malilimit lang sa isang plastic bag ang pwede nilang gamitin sa lahat ng mga wet goods na bibilhin nila. Hindi na pwedeng isang plastic sa fish tapos isang plastic din para sa mga meats.'

If buyers are planning to buy more than one type of wet goods, CENRO recommends they bring their own food containers to the market.

To ensure that both buyers and sellers are following this environmental move, the city will be imposing fines for those who will be caught violating the ordinance.

For first offense, they will be fined P500; for second offense, the fine will be P1,000; and P3,000 will be the fine for buyers caught on third offense.

Establishments caught in the first offense will receive a P3,000 fine with a stern warning; for the second offense, they will be fined P4.000 and an issuance of closure order for three months; and for third offense, they will receive a P5,000 fine with the cancellation of their business permit in the city.

The CENRO head is optimistic that the city will adapt to these changes especially with their plans to increase information dissemination efforts through conducting for a and seminar around the barangays in the city to teach residents about composting and proper waste segregation.

The Barangay Balatong Sanitary Landfill, which is now on its second phase of construction for its slope protection, is only taking the residual waste of the city.

Thus, the CENRO is hopeful that with the strict implementation of this ordinance, the landfill won't fill up quickly so it can serve the city for decades to come.

CENRO is hoping that all Laoageños will unify with this greening plan so the city can avoid possible hazardous effects of plastic in the environment.

DPWH completes flood control projects, farm to market road in Pangasinan

DAGUPAN (PIA) – The Department of Public Works and (DPWH)-Highways Pangasinan Second District Engineering completed two Office flood control projects in Pangasinan, aimed at strengthening the defense of flood risk communities in the province.

District Engineer Edita Manuel said that a 341-lineal meter riverbank protection structure was completed along Agno River Basin in Barangay Dorongan Valerio Mangatarem town, which will serve as protection of residents and agricultural lands nearby against damages caused by flood.

"Mangatarem has the biggest land area in the province of Pangasinan. It has protected land areas that have natural hot springs, but barangays located along the Agno River are vulnerable to flooding, especially during

CITY heavy rains and typhoons," Manuel said.

> A total of P45 million has been allotted under the Appropriations General Act (GAA) of 2022 for the completion of the project.

> Further, to ease perennial flooding in Dagupan City, flood control riverbank protection project Barangay Pantal upgraded.

> Manual said, "The lineal 148.95 meters of steel sheet pile with capping completed at the river mouth of Pantal river below the Pantal bridge, is designed for reinforcing defense strengthening the defense against flood."

> The project has a total cost of P19,730,000, funded under GAA of 2020.

> Meanwhile, DPWH-Pangasinan Fourth District Engineering Office completed the farm to

Beekeepers from Lamag Patiacan Culture Bee Association Quirino town Cosocos Honey Hunters Association of Nagbukel town participated to the three-day training held at BSU in La Trinidad, Benguet on December 5-7.

They were accommodated by three DOST provincial staff who will then be in charge of closely monitoring the said communities.

According to DOST, the participants underwent various activities beekeeping management for enterprise development as Introduction Beekeeping and Beekeeping Management; onsite visit at Carpio's Garden and Apiary (Beehive Management Hive Inspection and

Insect, Pest and Diseases Management, and Honey Harvesting); onsite visit at Cordillera Brotherhood Transport Services Apiary (Frame Introduction, Beehive Management, and By-product Processing Lip Balm Making); onsite visit at Limmayog's Apiary (Hive Inspection, Insects, Pest and Diseases Management, Introduction of Different Beehive Boxes); CRAC Apiary (Actual Rearing, Wax Foundation Installation, Wax Molding. Foundation Reboxing of Bee Nucs and Introduction to Stingless Bees).



PROVINCIAL ORDINANCE NO. 015-2022

AN ORDINANCE INSTITUTIONALIZING THE CELEBRATION OF THE LINGGO NG KABATAAN IN THE PROVINCE OF ILOCOS NORTE IN THE MONTH OF AUGUST EACH YEAR IN OBSERVANCE OF THE INTERNATIONAL YOUTH DAY, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES.

WHEREAS, Article II, Section 13 of the Constitution of 1987, mandates the State's recognition of the vital role of the youth in nation-building, promotion and protection of their physical, moral, spiritual, intellectual and social well-being, and states further its role to inculcate in the youth patriotism and nationalism, and encourage their involvement in public and civic affairs;

WHEREAS, Republic Act 8044 otherwise known as the "Youth in Nation-Building Act" creates the structures to implement a comprehensive and coordinated program for the youth and gives recognition to the youth's responsibility in fulfilling their vital role in nation-building;

(a) LINKS shall device the structures to implement a comprehensive and coordinated program for the youth and gives the following objectives:

WHEREAS, Chapter VI, Section 30 (a) of RA 10742 or the SK Reform Act, states that every province shall conduct an annual activity for the youth to be known as Linggo ng Kabataan on the week where the 12th of August falls to coincide with the International Youth Day;

WHEREAS, the Provincial Government of Ilocos Norte takes cognizance of the youth and attaining the vision of the province of creating a safe space for all, there is a need to enact enabling legislation to provide avenues for self-enhancement through various skills development competitions, trainings and seminars, and socializations.

NOW, THEREFORE, Be it Ordained that:

Section 1. Title – This shall be known and cited as the "Linggo ng Kabataang Sirib Ordinance."

Section 2. Definition of Terms – For this Ordinance, the following terms shall be defined as:

- (a) **LINKS** shall refer to the series of activities of Ilocos Norte in celebration of the Linggo ng Kabataan and International Youth Day for the month of August.
- (b) **Junior Officials** shall refer to the elected or appointed counterparts of provincial officials whose ages are from 13-17 years old.
- (c) **Subsidy** shall refer to the financial assistance given to the different city and municipal governments for the celebration of Linggo ng Kabataan.
- (d) **Youth** shall refer to all llocos Norte residents aged fifteen (15) to thirty (30) years old.
- (e) **Youth Organizations** shall refer to the different organizations in the Province whose members are composed of the youth.

Section 3. Institutionalization of the Linggo ng Kabataang Sirib (LINKS) –

- (a) There shall be an institutionalized annual celebration of the Linggo ng Kabataan on the week where the 12th of August falls to coincide with the International Youth Day.
- (b) The celebration shall be dubbed as Linggo ng Kabataang Sirib (LINKS).
- (c) The Ilocos Norte Youth Development Office shall be the lead implementing office of this program and shall also be in charge of organizing and coordinating with the different municipal and city governments for the effective implementation of this Ordinance.
- (d) The Ilocos Norte Youth Development Office shall, in coordination with the Ilocos Norte Youth Development Council and Panlalawigang Pederasyon ng Sangguniang Kabataan Ilocos Norte, promulgate specific guidelines for the celebration.
- (e) The LINK IN shall include different competitions along literary, performing and visual arts such as but not limited to debate tournament, photography competition, singing competition, dance competition, battle of the bands, digital poster making competition, quiz show, and essay writing competition.

Section 4. Objectives – The LINKS shall be designed to achieve the following objectives:

- (a) LINKS shall develop interest among the Ilocano youth relative to the arts and culture of the province and the country.
- (b) LINKS shall widen the youth development network amongst youth and youth organizations in the province.
- (c) LINKS shall enhance the artistic skills of the Ilokano youth through the different literary, performing and visual art activities.
- (d) LINKS shall serve as an avenue for the youth to generate additional source of finances for their education.
- (e) LINKS shall inculcate the spirit of camaraderie and

sportsmanship amongst the Ilocano youth.

Section 5. Junior Officials – The LINKS shall include the election of counterparts of all local provincial officials which shall include the Provincial Board Secretary, Members of the Provincial Board and District Representatives. The following positions shall be filled out by the Junior Officials:

- 1. Governor
- 2. Vice-Governor
- 3. Sangguniang Panlalawigan Board Members which includes the following ex-officio members:
 - a. Association of Barangay Councils Ilocos Norte President
 - b. Philippine League of Councilors Ilocos Norte President
 - c. Panlalawigang Pederasyon ng Sangguniang Kabataan– Ilocos Norte President
- 4. Provincial Board Secretary
- 5. District Representatives

The Ilocos Norte Youth Development Office shall, in coordination with the Ilocos Norte Youth Development Council and Panlalawigang Pederasyon ng Sangguniang Kabataan – Ilocos Norte, promulgate specific guidelines for the celebration.

Section 6. Duties and Functions of Junior Officials – The Junior Officials shall have the following duties and functions during their term:

- (a) Undergo mandatory trainings and workshops which shall include parliamentary procedure, public speaking, and legislative writing;
- (b) Create and propose draft legislative policies for the consideration of the Governor;
- (c) Simulate a regular session of the Sangguniang Panlalawigan;
- (d) Experience the functions of those they represent by being stationed at their respective offices; and
- (e) Perform such other duties and functions incidental to their role as Junior Officials.

Section 7. Celebration of LINKS in the City and Municipal Levels – In order to empower a great number of youth in Ilocos Norte, the Provincial Government of Ilocos Norte thru the Ilocos Norte Youth Development Office shall be providing subsidy to the municipal and city governments in implementing their own Linggo ng Kabataan and International Youth Day, in the amount of Fifteen Thousand Pesos (Php 15,000.00) for each LGU every year.

The Sangguniang Kabataan Federation Officers, together with the Municipal/City Youth Development Office concerned, shall use the subsidy and present a proposal to be approved by the concerned Local Chief Executive. The subsidy may be used for different literary competitions or youth empowerment training, seminar and workshop.

Accomplishment report on the City/Municipal celebration shall also be submitted to the Ilocos Norte Youth Development Office duly signed by the Local Chief Executive.

Section 8. Duties and Functions of Sangguniang Kabataan Officials and Katipunan ng Kabataan in the Barangay Level – The Sangguniang Kabataan Officials and Katipunan ng Kabataan

shall have the following duties and functions during the celebration of Linggo ng Kabataan and International Youth Day:

- (a) Disseminate information of their respective Municipal/ City and Provincial celebration of Linggo ng Kabataan to their constituents in the barangay;
- (b) Provide technical or logistical assistance to the youth in their barangays who are interested to join the different activities of the Linggo ng Kabataan;
- (c) Plan and implement programs and projects in celebration of the Linggo ng Kabataan within their barangay;
- (d) Submit accomplishment report to the concerned Sangguniang Kabataan Federated President and Local Youth Development Officer; and
- (e) Perform such other duties and functions incidental to their role as Sangguniang Kabataan and Katipunan ng Kabataan in the observance of Linggo ng Kabataan.

Section 9. Appropriations – The Ilocos Norte Youth Development Office shall incorporate in its annual budget an amount of at least One Million Five Hundred Thousand Pesos (Php1,500,000.00) for the effective implementation of this Ordinance.

Section 10. Implementing Rules and Regulations – Within 90 days from the effectivity of this Ordinance, the Ilocos Norte Youth Development Office shall promulgate the necessary rules and regulations for the implementation of this Ordinance.

Section 11. Repealing Clause – Any ordinance or issuance which is inconsistent with any provision/s hereof shall be considered repealed or rendered null and void.

Section 12. Separability Clause – If for any reason or reasons, any part or provision of this Ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

Section 13. Effectivity Clause – This Act shall take effect after its publication for three (3) consecutive weeks in a newspaper of general circulation and after its posting for the same duration in at least two (2) conspicuous places at the Provincial Capitol.



PROVINCIAL ORDINANCE NO. 016-2022

AN ORDINANCE AMENDING PROVINCIAL ORDINANCE NO. 061-2019, "AN ORDINANCE ENACTING THE ILOCOS NORTE INVESTMENT **CODE OF 2019".**

WHEREAS, the State recognizes the indispensable role of the private sector, encourages private enterprise and provides incentives to needed investments;

WHEREAS, the Provincial Government of Ilocos Norte (PGIN) recognizes the private sector as prime mover of economic growth and thus it encourages investments in desirable areas of activity;

WHEREAS, the PGIN, cognizant of the major role of investments from large enterprises in employment generation and economic growth, enacted Provincial Ordinance No. 061-2019, enacting the Ilocos Norte Investment Code of 2019;

WHEREAS, the past couple of years have brought abrupt changes in the business perspectives of people brought about by different factors, the greatest contributor of which is the COVID-19 pandemic, per a study conducted by McKinsey & Company, as contained in their COVID-19: Briefing note #100 published on April 13, 2022 at https://www.mckinsey.com/capabilities/riskand-resilience/our-insights/covid-19-implications-for-business;

WHEREAS, certain provisions in the Investment Code need enhancement, with emphasis on matters of fiscal incentives, to make it more responsive to current trends and the demands of time as well as to attract more investments, which changes would benefit both the Investors and the Province of Ilocos Norte.

NOW, THEREFORE, Be it Ordained that:

Section 1. Section 19, Chapter V of Provincial Ordinance No. 061-2019 shall have an added provision to read as follows:

d)LGUs, through their respective Business and Licensing Offices, shall submit reports to the INvest Office, all investment activities within their respective territorial jurisdiction. The Invest, in turn, shall forward the reports to the Board.

Section 2. Letter e, Section 24, Chapter VII of Ordinance No. 061-2019, is hereby amended to read as follows:

e)The enterprise shall employ at least 200 residents of the province, unless the work assignment requires highly technical and specialized skills, which cannot be undertaken by the local labor force of the province

Section 3. Section 31, Chapter IX of Ordinance No. 061-2019, is hereby amended to read as follows:

Section 31. Fiscal Incentives

A. New and Existing Businesses with the following fresh investments will

enjoy discounts on the provincial share of Basic Real Property Tax (RPT) for one calendar year. Businesses already enjoying real property discounts or exemptions under existing laws are not eligible of this fiscal incentive.

C. One (1) Year Governor's Permit Fee Exemption and Governor's Special Award for Environmental Excellence and to Business engaging in Solid Waste and Industrial Waste Project.

D. One (1) Year Governor's Permit Fee Exemption to Business incorporating Energy Efficiency and Conservation Project in their operations.

Section 4. A chapter in Ordinance No. 061-2019 is hereby added to read as follows:

CHAPTER XII JOINT VENTURE

SECTION 41. Joint Venture (JV)

Pursuant to Provincial Ordinance No. 006-2016, registered enterprises may opt to enter into a Joint Venture (JV) Agreement whereby a Private Sector Proponent (PSP) or a group of private sector entities on one hand, and the Provincial Government of Ilocos Norte on the other hand, contribute money/ capital, services, assets, including equipment, land, intellectual property or anything of value, or a combination of any or all of the foregoing.

The investment activity shall be for the purpose of accomplishing a specific goal with the end of facilitating private sector initiative in a particular industry or sector, and eventually transfer the activity to either the private sector under competitive market conditions or to the Provincial Government.

The JV involves the community or pooling of interests in performance of the investment activity, and each party shall have to direct and govern the policies in connection thereto with the intention to share both profits and risks and losses subject to agreement by the parties. A JV may be a Contractual JV or a Corporate JV.

Section 5. If any provision of this Ordinance is declared unconstitutional, the same shall not affect the validity and effectivity of the other provisions hereof.

Section 6. Any ordinance, executive order or issuance inconsistent herewith are hereby deemed repealed, amended or modified accordingly.

Section 7. This ordinance shall take effect immediately after compliance with the conditions required by pertinent provisions of the Local Government Code on the effectivity of ordinances.
