Avoid corruption, safeguard integrity: PBBM cautions PH councilors

President Ferdinand Marcos Jr. on Thursday warned local government officials to steer clear of corruption and to safeguard their integrity in serving the people.

"Never surrender to any form of temptation that will taint your integrity. Remember, as public servants we must uphold transparency, accountability in all our work," the President said to keynote the national convention of the Philippine Councilors League (PCL) held at the World Trade Center in Pasay City, Thursday.

In his speech, Pres. Marcos cautioned PCL members not to give in to temptation and avoid tarnishing their integrity.

As a public servant, the President said that what is done in the government should be kept clean and safe from accountability.

He said avoid doing corruption and steps that will damage the bureaucracy because it is a big liability to the law and deception to their constituents.

"Apart from inhibiting yourselves from corrupt practices, I also urge you to avoid unfairly the dangerous act that put the bureaucracy in a state of decay," he added.

He further told the councilors to focus on the welfare of their constituents and promote the corresponding measures to meet the needs of every sector of society.

It may be noted that the PCL is a local government organization of all the municipal and city councilors in the Philippines, and always at the forefront of contemporary and emerging trends in the local administration and development to help improve the quality of life of the Filipino people through effective local legislation. A lady once approached a priest and confided, "I feel guilty, Father. This morning, before coming to Mass, I committed the sin of pride. I sat for an hour in front of my mirror admiring my beauty." Will I have to do penance?

The priest, looking at her, replied: "Not at all, my child. You only have to do penance for a sin; not imagination."

In the gospel of this Fourth Sunday of Lent, we encounter people who, like that lady, are blind (read Jn 9,1-41). They are two kinds: one who is physically blind and people who are spiritually blind; one who wants to see and people who refuse to

Of the latter Jesus, who's referring to the Pharisees (Jewish religious leaders), says, "They have eyes but do not

These self-righteous leaders could not see because of hubris, an extreme form of pride, which could not accept Jesus' teachings and his profession that he was the Son of God. Because of this, the only recourse for them was to get rid of him and that happened in his crucifixion and death.

Aren't we in some ways like the blind Pharisees? For instance, among married couples there are those who insist strongly that they are always right until one is left (behind).

There are also those who are heavy smokers and drinkers and feel some pain. They are advised to go for physical check-up, but keep on postponing it. It's when they feel a big lump on the chest or stomach that they grudgingly give in. But it's too late and their days are numbered, they regret.

Loyzaga calls for end to gender inequality in mining sector

Environment Secretary Antonia Loyzaga has underscored the need for the mining sector to prioritize actions to end gender inequality as part of the effort to promote responsible mining.

In her keynote speech, Secretary Loyzaga underscored the need to ensure that women's representation in the mining industry is meaningful, substantive, and in all levels of decision making.

The environment chief discussed pressing issues affecting women, including indigenous women, in the mining sector and the impacts of the industry on communities.

She pointed to a 2020 scoping study commissioned by the Philippine- Extractive Industries Transparency

Initiative (EITI), which listed key issues women face in the mining industry, such as gender-inequalities intheworkplace, challenges they face as a result of environmental problems due to mining operations, lack of livelihood employment by mining firms, and absence of guidelines on the inclusion of genderresponsive projects in the Social Development and Management Programs (SDMP).

An SDMP, as required by the Philippine Mining Act, lays down the comprehensive five-year plan of a mining firm on how it would conduct its actual mining and milling operations toward the sustained improvement in the living standards of the host and neighboring communities.

Loyzaga lamented that women constitute the minority in the sector's workplace and only a few women occupy technical and leadership positions, prompting her to call for "an enabling and empowering environment for women."

"We hope that this will include the upscaling, strengthening STEM (Science, Technology, Engineering and Mathematics) education to motivate women to pursue careers that are very important and related to the industry," she said.

Loyzaga also noted that women are most affected by degradations linked to mining operations, such as pollution of rivers and drying up of water sources, and that "these have added pressures on women as household managers and also as providers."

The EITI-commissioned study likewise said that there are gaps in the context and implementation of policies and frameworks to address gender dimensions in the mining industry.

Loyzaga said this is one area that can be looked

into when revisiting the Philippine Mining Act of 1995. "We will be looking at this in tandem with the Magna Carta for Women," she added.

In closing, Loyzaga stressed that women should be recognized "not because they are women, but for the merit that they bring to the purpose of their organizations."

"We cannot just rest on our laurels and say we need to be recognized. We must be women of substance, women of purpose, and women of achievement," she pointed out. (*DENR*)
