Holy Week tourist arrivals soar to 43.53%-INTO

• Gov. MMM to make IN among Phl's premier tourist destinations

Tourist arrivals in Ilocos Norte during the Holy Week soared to 43.53% boosting economic growth in the province, local tourism officials reported.

The Ilocos Norte Tourism Office headed by Aian Raquel said this year's Holy Week tourist arrival rate was much higher compared to the same period in 2022 and 81.28% greater if tallied to that of 2019.

It expressed optimism that the local tourism industry in Ilocos Norte would likely rebound after it idled for years due to the COVID-19 global pandemic.

During last week's Lenten vacation, the tourists' favorite destinations included the St. William Cathedral and Sinking Bell Tower in Laoag City, the centuries-old Paoay church (a UNESCO World Heritage site), Saint Padre Pio Hilltop Hermitage in (Davila) Pasuquin, the Bangui Windmill farm, the Kapurpurawan (White) Rock Formation in Burgos, St. John the Baptist in Badoc, Malacañang of the North in Paoay, the La Virgen Milagrosa Cove and Chapel in Badoc, Cape Bojeador Lighthouse in Burgos, the Blue Lagoon beach resort in Pagudpud, Madongan Dam n Dingras, and Paoay Sand (Pls. turn to page 3)

PVAO reminds public, youth on contribution of war veterans

The Philippine Veteran Affairs Office (PVAO) reminded the public, especially the youth, of the great contribution of war veterans to the country's freedom.

According to Adeadatus Retuta, PVAO La Union Head, the Philippine Veterans Week set every April 5-11 annually pursuant to Proclamation No. 466 series of 1989 is not just a mere observance and that the Day of Valor annually commemorated every April 9 in accordance to Executive Order No. 203 series of 1987 is not simply a non-working holiday.

Retuta noted that said observances were institutionalized to promote, preserve, and memorialize the bravery of the Filipino soldiers who sacrificed their own lives to liberate and protect the country from foreign invaders.

"Sometimes we tend to forget that the freedom we are enjoying today is a manifestation of the sacrifices our war veterans have done,"

It meant sure death, but fortunately his hand grabbed the branch of a tree which stopped his fall. Hanging precariously with the branch about to give way, he prayed aloud, "Lord, if you are up there, save me!"

A booming voice answered, "Yes, this is God." "Dear God, please help me," said the man desperately.

"Yes, I'll help you," replied the Lord. "But do you trust me?" "Of course, Lord, I trust you," the man replied.

"Then let go of your hold!" ordered God. "I'm begging God to save me and he's telling me to 'let go.' What a nonsense!" muttered the puzzled man. So he looked up again and hollered, "If there's anybody else up there... help!"

DOH advises Ilocos residents to boil water for drinking to prevent the spread of diarrhea

Health – Ilocos Region today advised residents to boil their drinking water if there is no supply of potable water available to avoid getting diarrhea and other waterborne diseases.

Due to the very hot and humid weather, cases of diarrhea are on the rise which commonly affects children.

"Because of their playful trait, children need a lot of fluid to rehydrate after playing and they usually drink directly from tap water or from other sources such as juices being sold by ambulant vendors frequenting the streets."

"We have to make sure that we have potable water at home and that the water we serve our children are safe and assured residents

The Department of clean. Always use pure clean water for drinking, preparing beverages, cooking, brushing teeth, washing hands and face washing and eating and cooking tools to avoid getting diarrhea," Regional Director Paula Paz M. Sydiongco stated.

> "Kung hindi tayo sure sa iinuming tubig, pakuluan natin ito ng at least one minute to kill any harmful bacteria. Sydiongco also that diarrhea cases in the region are manageable various medical commodities were already prepositioned to prevent an outbreak of diarrhea cases in the provinces.

Regional manager for the food and waterborne disease prevention and control program, Ms. Kaye T. Valdez said that the provincial health offices of Ilocos Norte, Ilocos Sur, La Union and Pangasinan including the city health office of Dagupan City have already received their supply.

"We have given 140 jars of effervescent chlorine granules to be used for water disinfection, 1,200 boxes ciprofloxacin, antibiotic for adults to treat different types of bacterial infections, 2,016 bottles of zinc syrup for Ilocos Region)

kids to strengthen their immune system and metabolism function, 35,120 sachets of oral rehydration solution to restore body fluid and prevent dehydration and 35 boxes of crystal VC RDT kits for the detection of cholera."

According to the Regional Epidemiology and Surveillance Unit (RESU), there are a total of 4712 acute watery diarrhea cases reported by various disease reporting units (DRU) in Region 1 from January 1 to March 25, 2023, with 7 deaths recorded.

Region 1 Police Top Brass and Drug Operatives pass Surprise Drug Test

BGEN **CAMP** OSCAR M FLORENDO -Police Regional Office 1 conducted a surprise drug test on senior officers and drug operatives assigned at the Regional Headquarters a command during conference on Wednesday morning, April 12, 2023.

Based on the report the Regional Forensic Unit 1, 38 Police Commissioned Officers including PRO 1's senior officers, and 7 Police Non-Commissioned Officers were subjected to a drug test and all tested negative for use of dangerous drugs.

Police Brigadier General John C Chua, PRO 1 Regional Director led the said drug test while all attendees were prohibited to leave the conference room without being tested.

Meanwhile, before the conference, the Regional Forensic Unit 1 also subjected 29 operatives from the Regional Drug Enforcement Unit surprise drug tests and all also tested negative for drug use.

"The conduct of this drug test is a part of our regular and continuous effort in sustaining the gains of the PNP's Internal Cleansing program," **PBGEN** CHUA during the conference.

"The implementation intensified our campaign against illegal drugs must start within our organization and I am happy to note that Police Regional Office 1 remains to be a drug-free organization," he averred.

11 people died of drowning in P'sinan during Holy Week break – PNP

DAGUPAN (PIA) – The Philippine National Police (PNP) reported 11 deaths due to drowning in Pangasinan as a large number of visitors trooped tourist destinations in the province during the long Holy Week break.

In an update on Monday, the PNP said three incidents happened in Dagupan City on April 8 wherein two drowned in a river and one drowned at the beach.

Beach drowning incidents were Bolinao, reported in Alaminos City, and Infanta on April 8 as well as in Lingayen on April 9 with one death each.

Aside from Dagupan City, drowning incidents were recorded in rivers in Tayug and Mabini on April 5 and Sto. Tomas on April 9.

Further, one drowned in a resort in Sison town on April 8.

Meanwhile, the city government of Dagupan clarified that only one drowned in Sitio Suit, Barangay Pugaro April 8 contrary to a post circulating online stating that eight beachgoers drowned in the area.

The victim was taken away by the strong current of the sea and eventually disappeared.

Later, relatives and co-workers saw the body of the victim floating at the sea, lifted him, and gave him first aid.

victim The brought to the Region 1 Medical Center in Dagupan City but was declared dead on arrival.

DOLE intensifies anti-child labor campaign

The elimination and labor in the country. prevention of child labor remain a top priority of the Department of Labor & Employment (DOLE) as it vows to boost its efforts in eradicating child labor in the country.

Aside the continuous push for antichild labor campaigns, Department – as National Council Labor Child (NCACL) chair, leads the development of the Philippine Program Against Labor Child (PPACL) Strategic period 2023-2028.

The PPACL works transform the lives child laborers, their families, and communities toward their sense of selfempowerment, worth, and development. It also been working towards preventing and progressively eliminating labor through child protection, withdrawal, healing, and reintegration of child workers into a caring society. It supports the alleviation of extreme poverty, which has been the leading cause of child

DOLE Secretary Bienvenido Laguesma saidd the DOLE extends necessary services profiled child laborers as a contribution to the PPACL.

"The DOLE been implementing the Child Labor Prevention and Elimination Program provides services them and families through direct intervention or referral to appropriate agencies and organizations," Laguema

From 2018-2022, Framework covering the the DOLE has profiled 620,556 child laborers, referred 614,066 appropriate agencies and organizations, provided 138,460 essential services, and withdrawn 148,248 from child labor. For 2023, the DOLE will prioritize monitoring 160,288 child laborers profiled in 2022.

The DOLE continue to conduct various advocacy activities using quad-media platforms to raise awareness and gather support in the campaign against child labor, strengthen the capacity of DOLE Regional Offices

labor inspectors, social partners, and other stakeholders at the national and local levels, issue Working Child Permit (WCP) to children below 15 years of age that falls under the exceptions to the prohibition provided under Republic Act No. 9231, enforce anti-child labor laws in workplaces through the Labor Inspection Program, profile child laborers to locate and identify children engaged in child labor, rescue child laborers through Sagip Batang Manggagawa and other similar mechanisms, and provide assistance to profiled child laborers and their families, especially livelihood assistance, to facilitate the removal of children from child labor.

According to Special Release Working Children Situation for 2019 to 2021 published by the Philippine Statistics Authority (PSA) posted on 03 March 2023, there were 1.37 million working children, 935,000 of whom were engaged in child labor.

The release identified the agriculture sector as the top industry with the most child laborers tagged Northern Mindanao Region with the highest child labor incidence.

With the increased number of child laborers, the Department doubled its efforts in monitoring profiled child laborers to facilitate their removal from child labor.

"The Marcos administration remains steadfast in prioritizing

the elimination of child labor in the country. Under Chapter 3 of the Philippine Development Plan 2023-2028, the target for the indicator number of child laborers is zero," Laguesma said (dole/pia-ncr)



COMES NOW the petitioner in the above-entitled thru the undersigned counsel and unto this Honorable Court, respectfully allege:

- 1. That petitioner is of legal age, Filipino citizen, married to Johna Paula Bayded-Agonoy and a resident of Brgy. 13, San Gabriel I, Bacarra, Ilocos Norte, Philippines, while respondent is his wife, likewise of legal age, Filipino citizen and presently a resident of 505 Gabong Bayan St., Darangan, 1940, Binangonan, Rizal, Philippines where she may be served with court processes;
- 2. That petitioner and respondent came know each other in February 2000 when petitioner was then working as service crew of Jollibee while respondent was working at the "carinderia" of her aunt Neneth Cadiente Bacarra, llocos Norte. After a few days, petitioner courted the respondent and after a month, they became sweethearts. Whenever she would be in Manila, they would communicate through letters. - That on November 10, 2000, petitioner left for Saudi Arabia and instructed the respondent to return to her parents in Binangonan, Rizal and continue her studies in Metro Manila, giving her a monthly allowance P5,000.00 instructing her that they would communicate to each other by telephone at exactly 7:00 o'clock in the evening while petitioner was abroad. That however, there were times when they would quarrel over the phone because of the failure of the respondent to answer his calls text messages and immediately especially when respondent would still be in school or when petitioner would learn that respondent went out with her friends without his knowledge or when respondent would criticize him or goes against his thinking, ideas and plans or when respondent would remind him of his behavior;
- 5. That in late 2002, Neneth Cadiente, the aunt of respondent became severely ill that she needed someone to take care of her and out of respect and love for her aunt, respondent discontinued her studies and came home to take care of her aunt; She consulted her husband of her decision but petitioner accused respondent of having an affair and threatened to stop her allowance;

PH, UK to take environment and climate partnership to new heights
