At the height of the provincial fiesta, the Provincial Government of Ilocos Norte said it expects more incoming visitors here to attend the Himala sa Buhangin music and arts festival to be held at the Paoay Sand Dunes in Paoay, Ilocos Norte.

Guest Editorial:

West Philippine Sea is a potential flash point

Tension is again rising over the West Philippine Sea (also known as South China Sea), which has now become a potential flash point in the fight for geopolitical edge between China and the United States.

The tense situation came about after China criticized the recent Balikatan war exercises jointly conducted by the Philippine and U.S. forces. China described the military drills as "provocative.'

China has also criticized Manila for allowing the U.S. to have access to four military bases in Luzon, aggravating further the tense situation.

Recent near-clashes between the Chinese coast guards and Philippine coast guards in the West Philippine Sea have likewise added fuel to the smoldering conflict.

But it is reassuring to note that President Ferdinand Marcos Jr and his foreign secretary met with Chinese Foreign Minister Qin Gang on Saturday (April 29) with both countries pledging to work together to resolve maritime issues in the South China Sea.

The talks held in Manila marked the latest in a series of high-level meetings of the Philippines with leaders of the United States and China as the two superpowers battle for strategic advantage in the Indo-Pacific.

"As to the conflicts, we agreed to establish more lines of communications so that any event that occurs in the West Philippine Sea that involves China and the Philippines can immediately be resolved," Marcos said.

Marcos said Qin's visit was helpful in talking things through and continuing work on improving the relationship between the two neighbors.

Qin and his counterpart, Philippine Foreign Secretary Enrique Manalo, discussed views on strategic and regional issues during bilateral talks. Qin said the two countries needed to work together to continue a tradition of friendship, deepen cooperation and properly resolve differences.

Working together would help promote peace and stability

of the region and the world, he added.

Manalo reaffirmed the Philippines's adherence to the One China Policy, while expressing concern over the escalating tensions across the Taiwan Strait. China's ambassador to the Philippines caused last week a stir when he accused Manila of "stoking the fire" of regional tensions by offering expanded military base access to the United States, which he accused of interfering.

Manila's foreign minister said relations with Beijing are more than just their differences over the South China Sea, which sees the passage of about \$3 trillion worth of shipborne goods annually.

"These differences should not prevent us from seeking ways of managing them effectively, especially with respect to enjoyment of rights of Filipinos, especially fishermen," Manalo said.

From our standpoint, we see the Philippines as doing a very dangerous balancing, highwire act: It wants to be a good neighbor of China and at the same time a good friend of the

Last April 27, I was invited by the Greeters and Collectors (G&C) of my home parish, San Roque de Mandaluyong, to talk about joy and humility in service. Although I was notified by my friend (who was supposed to bethe speaker but had to beg off) eight hours before, I decided to give it a go (why not!) and proceeded to begin working on my slide presentation. And, yes, I accepted the invitation because almost all of the G&C members and officers are my friends, second tita, and second nanay (thank you, TitaEyaGarces and G&C, for the rare opportunity) and it was perhaps the first time in the history that I would be talking before my elder fellow parishioners about servant leadership.

What does servant leadership really mean?

To put it bluntly, servant leadership means putting others' interests over one's own. However, this does not mean that we have to sacrifice our own personal needs because one cannot give what one does not really have. Empty cups do not overflow with blessings whereas full ones do. A multi-million-peso medical center soon to rise in SFdo

SAN FERNANDO CITY, La Union (PIA) — A multi-million medical center that will soon rise along Pennsylvania Avenue, Barangay Madayegdeg in this city is expected to boost the delivery of health care services to residents of La Union.

Dr. Cecille Faye L as a m - Perdigon, founding member of the hospital, said that the administration of St. Jude Thaddeus Medical Center is expected to be completed by 2026.

"Inaasahan po naming magsisimula ang pagpapatayo ng ospital on the last quarter of 2023 hanggang first quarter ng 2024 at maitatayo ito pagkatapos ng 2 hanggang 3 taon," Lasam-Perdigon said in an interview.

She reiterated that the seven floors with a capacity of 103 beds will be completed in 2026.

"St. Jude Medical Center also features modern ICU, PICU, and NICU Complexes, modern delivery operating and complex, room laboratory and diagnostic centers, at marami pang iba," said Dr. Lasam-Perdigon.

The establishment of the health facility would help decongest other health facilities as it will augment other medical hospitals in the province.

LANDBANK lending P6 billion to support Pangasinan dev't plan

DAGUPAN (PIA) – The Land Bank of the Philippines (LANDBANK) supporting the provincial government of Pangasinan with a P6-billion loan fast-track various priority transportation, health, education, tourism development and urban township projects of the province.

In a statement on Thursday, LANDBANK President and Chief Executive Officer Cecilia Cayosa Borromeo said "The P6-billion loan is in full support of Pangasinan's development agenda towards a more inclusive, resilient, sustainable local economy."

"This investment also underscores L A N D B A N K 's collaborative efforts for

the province's growth trajectory anchored on the efficient delivery of public service," Borromeo said.

During his State of the Province Address (SOPA) last March, Governor Ramon Guico III also bared, "The Land Bank of the Philippines, just like the tourists and investors who are now coming to our province, know that they can trust the province of Pangasinan. Our omnibus loan that amount to P6 billion will finance almost all our projects."

Majority of the P6 billion omnibus term loan agreement worth P2.85 billion will fund big-ticket infrastructure projects designed to enhance mobility and upgrade healthcare services in Pangasinan.

Sen. Marcos leads cash aid payouts in eastern Pangasinan

DAGUPAN CITY (PIA) -- Senator Imee Marcos visited the eastern portion of Pangasinan on Sunday to lead the distribution of cash aid under the Assistance to Individuals in Crisis Situation (AICS) program of the Department of Social Welfare and Development (DSWD).

Three municipalities in the eastern part of the province were visited namely, Villasis, Asingan, and Rosales, wherein each town had 1,000 identified beneficiaries.

The 3,000 recipients were comprised of solo parents, indigents, senior citizens, persons with disabilities, barangay health workers, out-of-school youths, members of civilian volunteer organizations, and small-scale vendors.

Each recipient was given P3,000.

In her keynote message, Marcos said the cash assistance aims to somehow help the beneficiaries ease up the burden brought about by the pandemic.

"Hindi na po ako magiisip kung saan kukuha ng pambili ng maintenance ko, maraming salamat po Senator Imee," she said.

SSS runs after delinquent employers in Vigan City

VIGAN CITY, Ilocos Sur (PIA) – The Social Security System (SSS)-Vigan Branch gave delinquent employers 15 days to comply with their member-employee contributions after the first Run After Contributions Evaders (RACE) done by the branch on Friday, April 28.

The team, led by branch head Cecille Sally and accompanied by their legal officer, Lawyer Warden Domingo from the Luzon North Legal Operations Department, visited five non-compliant employers -both big and small including an enterprise, a one-stopshop, a burger stand, a bus company, and a restaurant to remind them of their obligations.

Employers were presented with the billing letter, statement of account, and an order stating that they are demanded to settle their obligations within the provided period

from the day they received the said order.

According to legal officer Domingo, failure to comply will compel the SSS to take legal actions against the employers.

However, the SSS provides options for the employers where they can avail an installment payment scheme or the contribution penalty condonation program.

For the former, Sally explained that the employers must pay a down payment of not less than five percent of the amount of delinquency, meanwhile the balance is payable up to 48 months depending on the total amount of delinquency.

For the latter option she said, "They just have to visit our office, as long as they are qualified for the condonation program where the penalties will be waived and after that they will only need to pay their past-due SSS



PROVINCIAL ORDINANCE NO. 024-2023

AN ORDINANCE PRESCRIBING FOR THE ALLOCATION OF AT LEAST TEN PERCENT (10%) OF THE TOTAL PROCUREMENT VALUE OF THE PROVINCIAL GOVERNMENT OF ILOCOS NORTE, NGAS, RLAS AND OTHER GOVERNMENT AGENCIES HOLDING OFFICES IN ILOCOS NORTE, FOR LOCALLY, PRODUCED GOODS AND SERVICES AND THEIR MANDATORY PROMOTION THEREOF.

WHEREAS, Article II, Section 20 of the 1987 Constitution provides that the State recognizes the indispensable role of the private sector, encourages private enterprise, and provides incentives to needed investments:

WHEREAS, Republic Act No. 9501 or the Magna Carta for Micro, Small and Medium Enterprises (MSMEs) recognizes that MSMEs have the potential for more employment generation and economic growth and therefore can help provide a self-sufficient industrial foundation for the country, and thus declared the policy of the State to promote, support, strengthen and encourage the growth and development of MSMEs in all productive sectors of the economy particularly rural/agri-based enterprises;

WHEREAS, Section 4 of Republic Act. No. 9501 or the Magna Carta for MSMEs provides that eligible MSMEs shall be entitled to a share of at least ten percent (10%) of total procurement value of goods and services supplied to the government, its bureaus, offices and agencies annually;

WHEREAS, to qualify under this Ordinance, the requirements set forth in Section 4 of Republic Act. No. 9501 of the Magna Carta for MSMEs are hereby adopted:

WHEREAS, the Province of Ilocos Norte has approximately 11,230 MSMEs who are into manufacturing/processing, making up at least 99% of the total number of registered businesses in the province;

WHEREAS, the Provincial Government of Ilocos Norte has a legal and moral obligation to recognize the specific needs of the MSMEs and shall undertake to promote entrepreneurship, support entrepreneurs, encourage the establishments of MSMEs and ensure their continuing viability and growth and thereby attain countryside industrialization;

NOW THEREFORE, be it ordained by the Sangguniang Panlalawigan in session duly assembled, that:

Section 1. Short Title. This Ordinance shall be known as the "MANDATORY PROMOTION AND PROCUREMENT OF LOCALLY-PRODUCED GOODS AND SERVICES";

Section 2. Definition of Terms. As used in this Ordinance, the following terms shall mean;

- (a) Locally-produced goods and services These are food and non-food products and services made/provided in the Province of Ilocos Norte;
- (b) MSME Micro Small and Medium Enterprise, including cooperatives, rural improvement clubs, associations and existing businesses without registrations, with a capitalization not exceeding Php100 Million; has an existing product, food or non-food, or has commenced operation but is in the process of developing its product;
- (c) Pasalubong Centers Provincial Government-administered outlets where MSMEs may display/sell their products;
- (d) Rural/Agri-Based Enterprise businesses that are into:
 - (i)agricultural production; and/or
 - (ii)processing agricultural produce/raw materials into finished goods;
- (e) Tourism-related Establishments establishments offering services in support to tourism such as hotels, restaurants, shops, museums, training centers, homestays, sports and recreation clubs, among others;

Section 3. Coverage and Eligibility for Assistance. To qualify under this Ordinance, businesses must be:

- (a) all manufacturing, processing, and/or production of agricultural produce and provision of services which are duly registered with the appropriate agencies as presently provided by law (DTI, SEC, CDA or DOLE) and have the requisite Mayor's permit, including other statutory registrations;
- (b) one hundred percent (100%) owned, capitalized by Filipino citizens, whether single proprietorship or cooperative. If the enterprise is a juridical entity, at least sixty percent (60%) of its capital or outstanding stock must be owned by a Filipino citizen residing in the province; and
- (c) a business activity within the major sectors of the economy, namely: industry, trade, service, including the operation of tourism-related establishments, and rural/agri-based enterprise;

Section 4. MSME Registry. Within three (3) months after the effectivity of this Ordinance, the Technology and Livelihood Development Office, in coordination with the Negosyo Center of the province and all barangays/cities/municipalities, shall submit to the Governor and the Sangguniang Panlalawigan a complete list of MSMEs eligible to avail the benefits of this Ordinance.

PROVINCE OF ILOCOS NORTE

The list shall be known as the "MSME Registry" and shall serve (c) Regularly coordinate with National Government Agencies as the basis of the procurement of locally-produced goods and services;

The MSME Registry shall be posted in the official website of the Province and shall be subjected to validation by the office of the Governor, in coordination with the Department of Trade and Industry and various CSOs in the Province within 3 months from posting thereof. The registry shall be subject to periodic updating once every two (2) years following the effectivity of this Ordinance.

Section 5. Statement of Policy. The Provincial Government believes that the role of MSMEs is vital in the prosperity of the Province. At least 99% of the businesses registered compromise of the processing/manufacturing/service sectors, and they contribute much to the resources of the Province. With reference to this data, the Provincial Government deems it necessary to develop a vibrant MSME sector by improving their access to market within 5 years from effectivity of this Ordinance.

Section 6. Program Guidelines. The various programs, projects and activities to be implemented by virtue of this Ordinance shall be guided by the following principles:

- (a) In every purchase of goods and services by the Provincial Government, NGAs, RLAs and other government agencies holding offices in Ilocos Norte, consideration must first be made whether or not there are local counterparts of these products/services deemed to be purchased;
- (b) All tokens to be given in all activities of the Provincial Government, NGAs, RLAs and other government agencies holding offices in Ilocos Norte must be locally-produced goods and/or services;
- (c) At least eighty percent (80%) of the goods displayed in Provincial Pasalubong Centers must be locally-produced;
- (d) At least ten percent (10%) of total procurement value of goods and services supplied to the Provincial Government, NGAs, RLAs and other government agencies holding offices in Ilocos Norte annually must be solely devoted to locally -produced goods and services;
- (e) Development of MSMEs to act as consolidators of locallyproduced goods and services to help facilitate marketing of these products;
- (f) Establishment of more Pasalubong Centers or market outlets for MSMEs to display/sell their products;

Section 7. Primary Implementing Offices. The General Services Office (GSO) and the Micro, Small & Medium Enterprise Office (MSME Office) or any unit/division within the LGU with similar function must ensure that the provisions of this Ordinance are strictly observed. They are hereby tasked to be the Primary I HEREBY CERTIFY to the correctness of the above-quoted Implementing Offices with respect to the procurement as embodied Provincial Ordinance No. 024-2023. in this ordinance.

As such, the primary Implementing offices are mandated to:

- (a) Prepare the general rules and guidelines implementing the provisions of this Ordinance and submit the same to the Sangguniang Panlalawigan for its review and approval, within three (3) months after this ordinance shall have taken effect, in coordination with each other;
- (b) Design and prepare a Procurement and Marketing Plan for MSMEs Products to be carried out pursuant to the provisions of this Ordinance, subject to the approval of the Governor and the availability of funds. For purposes of defining tasks, the GSO shall implement the procurement activities while the TLDO shall undertake the marketing activities;

- (NGAs), Regional Line Agencies (RLAs) and other government agencies holding offices in Ilocos Norte with respect to the strict implementation of the provisions of this Ordinance;
- (d) Submit semi-annual report to the Office of the Mayor/Governor and to the office of the Vice-Mayor/Vice-Governor of the status of implementation of this Ordinance;
- (e) Exercise such other functions expressly granted and those necessarily implied therefrom, as well as those functions necessary, appropriate and incidental to the effective and efficient implementation of the provisions of this Ordinance;

Section 8. Funds. Aside from the mandatory 10% procurement requirement, the City/Municipal Mayor/Governor, within one (1) year after this Ordinance shall have taken effect, shall propose the necessary appropriation of funds to be used in the implementation of the (City/Municipal/Provincial) Government's Procurement and Marketing Plan for MSME products to be taken from the General Funds, subject to the approval of the Sangguniang Panlalawigan;

The (City/Municipal/Provincial) Government is hereby authorized to accept funds from other GOs, NGAs, RLAs, NGOs, CSOs, Pos and the Business Sector to be used in the implementation of the Procurement and Marketing Plan, subject to proper government accounting and auditing procedures.

Section 9. Separability Clause. If for any reason or reasons, any part or provision of this Ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall stand and continue to be in full force and effect.


Repealing Clause. All local ordinances and Section 10. enactments, executive orders, resolutions, memoranda, circulars or any part thereof contrary to or inconsistent with the provisions of this Ordinance is hereby repealed, modified or amended accordingly.

Section 11. Effectivity Clause. After due public hearing, this Ordinance shall take effect after fifteen (15) days following its complete publication in at least one (1) local newspaper of general circulation.
