The Department of Health (DOH) - Ilocos Region has already rolled out the COVID-19 Vaccine Pfizer Bivalent in various government units in the region for vaccine deployment and vaccination campaign for the A1 (frontline workers in health facilities both national and local, private and public, health professionals and non-professionals like students, nursing aides, janitors, barangay health workers, etc.) and A2 (senior citizens aged 60 and above) priority groups.

"All provincial and local vaccination operations centers (P/LVOCs) implementing units and hospitals, are ready and prepared for the roll-out and deployment of vaccination teams in their respective areas," Regional Director Paula Paz M. Sydiongo stated.

The bivalent Covid vaccine were initially rolled-out in public health facilities including Marcos Memorial Hospital and Medical Center (290 vials), Ilocos Sur Medical Center (50 vials), Ilocos Sur Provincial (Pls. turn to page 5)

# CSC reiterates advocacy against smoking within bureaucracy

A the nation observe National No Smoking Month this June, the Civil Service Commission (CSC) reiterates its advocacy against smoking within the bureaucracy as adopted and promulgated through CSC Memorandum Circular (MC) No. 17, s. 2009 or the Smoking Prohibition Based on 100% Smoke-Free Environment Policy.

CSC Chairperson Karlo Nograles said this is not just for the welfare of civil servants but of all individuals visiting government offices as well.

"Ang paninigarilyo ay nananatiling isa sa mga pangunahing sanhi ng pagkakaroon ng malulubha at nakamamatay na mga sakit, kaya nananawagan ako sa lahat ng government agencies na istriktong ipatupad ang ating polisiya laban sa paninigarilyo sa mga government premises, para sa kapakanan ng ating mga kawani at lahat ng mga taong pumupunta sa ating mga tanggapan," said Chairperson Nograles.

The Smoke-Free Environment Policy absolutely prohibits smoking in the premises, buildings, and grounds of government agencies providing health, education, and/or social welfare and development services such as hospitals, health centers, schools and universities, colleges, among others. This means no smoking areas may be designated or established in these places.

For all other government agencies not part of the aforementioned absolute prohibition, they are allowed to have one (1) designated smoking area in their premises with the following conditions: located in an open space with no permanent or temporary roof or walls in an outdoor area; not located within 10 meters of entrances, exits, or any place where people pass or congregate; does not have an area larger than 10 square meters; and have highly visible and prominently displayed "Smoking Area" signages. Moreover, food and drinks are not allowed to be served in the designated smoking area.

Government officials and employees are also prohibited from engaging in unnecessary interactions with the tobacco industry under CSC-Department of Health (DOH) Joint Memorandum Circular 2010-01 or the Protection of the Bureaucracy Against Tobacco **Industry Interference.** 

According to the said rule, prohibited acts include giving preferential treatment such as incentives or exemptions to the tobacco industry; soliciting or accepting gifts, donations, and sponsorships in connection with any operation or transaction of their office; and having financial or material interest in any transaction involving the tobacco industry requiring the approval of their office.

The CSC Chair strongly emphasized the importance of government agencies rallying behind the implementation strategy for health promotion outlined in the Joint Administrative Order No. 2023-0001 or the National Policy Framework on the Promotion of Healthy Workplace.

Launched by the CSC, DOH, and Department of Labor and Employment on 28 April 2023, the policy framework's primary objective is to foster and establish healthy workplaces, with a particular focus on addressing substance use, particularly tobacco use, as one of the priority areas requiring health promotion interventions.

The deadly effects of smoking not only on the smoker's health but also for non-smokers who become victims of secondhand smoking are well-documented, with studies linking it to various health conditions such as cardiovascular disease, cancer, and respiratory issues. It is a major public health concern, and as civil servants, it is our sworn duty to lead the way in curbing issues that are detrimental to public interest," Nograles said.

Pursuant to Presidential Proclamation No. 183, s. 1993, June is celebrated nationwide as National No Smoking Month.

The proclamation extends the observance of World No Tobacco Day, which is observed annually on 31 May to a whole month in order to intensify the campaign against smoking by raising public awareness of its ill effects. (csc/pia-ncr)

In today's gospel, Jesus declares: "If they persecuted me, they will also persecute When he talked of persecutions, he was referring to the persecutions his disciples had suffered at the hands of the Jews and the Romans in proclaiming his teachings.

Today, the persecutions are no longer happening what Jesus experienced then. Now there are hostile, totalitarian non-Christian countries who oppose the Christian beliefs and even forbid their presence.

Other forms of persecutions are likewise happening in our Christian country. For instance, there are denominations that attack and criticize the doctrines and practices of others. They find fault in Catholics as idolators, claiming that they are

statues of saints. For the record, Catholics are not idolaters. They are not adoring the pictures or wooden statues but rather the holy persons that are represented.

There are those in parish organizations and religious communities who quit or "lie low" because they had been unjustly treated or hurt by a criticism or a nasty remark. They surely have good reason to do it. However, a steadfast faith should help them recover and not isolate themselves for

Other forms of persecution may be suffering from a strict and overbearing spouse or being ridiculed because he or she is actively serving the church.

Ask yourself: When there "worshipping" the images and are trials and persecutions, do

Even in that extreme situation where prisoners survive on meager ration, Frankl recalled, there were "men who walked through the huts comforting others, giving away their last piece of bread."

Subjected to hunger and physical deprivations, these inmates could have become selfish, grasping but they opted instead to share the little that they had. "Do not fear those who

The Department of Health (DOH) – Ilocos Region awarded a total of 63 barangays as winners of the 'DOH Defeat Dengue Drive Contest: Search for the Most Prepared Barangay' held in the entire month of June in the province of Ilocos Sur with every barangay in every municipality automatically entered as a participant.

The regional office spearheaded the contest Health through its Promotion Unit in partnership with the Provincial Health Office of Ilocos Sur and conducted it simultaneously in all 34 municipalities of the province.

According to Regional Director Paula Paz M. Sydiongco the contest was conducted in preparation for the rainy season and also to remind communities of the enhance 4S strategy against dengue which stands for — search and destroy breeding sites; seek early consultation; self-protection; and saying 'yes' to fogging only in hotspot areas where an increase in cases is registered for two consecutive weeks.

# City civil registry conducts barangay civil registration system

FERNANDO She SAN CITY, La Union --The Office of the City Registry, in cooperation with the Philippine Statistics Authority-Regional Office I (PSA-RO1), conducted the Barangay Registration Civil System (BCRS) training providing barangay officials an information system to record and manage demographic and biographic information about their residents.

Pursuant to Section 394 of the Local Government Code of 1991, Barangay Secretaries are mandated to "assist the municipal civil registrar in the registration of births, deaths, and marriages (e)" and "keep an updated record of all inhabitants of the Barangay (f)".

City Civil Registrar Ms. Evelyn A. Guhit emphasized the importance of their active involvement in updating their database. She highlighted that conceptualization and implementation of programs, projects, and activities in the City must be grounded on and/or influenced by data.

Also present as resource speakers of the training were Chief Administrative Officer Ms. Camille Carla U. Beltran, and Statistical Specialist II Mr. Joseph Estoesta of the PSA-RO1.

# La Union observes National Dengue Awareness month

FERNANDO SAN (PIA) Provincial Government of La Union, through the Provincial Health Office, led the Dengue Awareness Celebration Month with the theme, "Fight Dengue, Save Lives" at Barangay Mindoro, Bangar, La Union on June 16 to awaken community involvement and intensify awareness against dengue outbreak.

A "Larval Survey and Search and Destroy" among 100 households of the barangay kickstarted the activity, which was participated in by medical staff from the municipal health office and barangay health workers.

Aside from that, the PHO installed insecticide-treated curtains as the barangay conducted the fogging operation.

In his lecture, Dr. Rheuel Bobis, Medical Officer IV of the Department of Health-Center for Health

Development 1 (DOH-CHD1), said that dengue is everybody's concern.

"As of monitoring natin, From January 1 to June 11, 2023, sa probinsya po ng La Union, ngayong 2023, nagkaroon po tayo ng 195 ng bagong kaso ng dengue, comparing last year na nasa 73 lamang po ang kaso ng dengue, at meron pong naitalang kung namatay, kaya't nakakaalarma,'' Dr. Bobis reiterated.

Among the barangays of Bangar, Mindoro recorded a total of 16 cases of dengue which is considered to have the highest case with three deaths logged in 2022.

Dr. Bobis reminded the town's constituents that dengue control could be addressed effectively with the community's involvement.

# Loyzaga seeks private sector's support and collaboration for climate action, sustainable communities

Environment for Antonia Secretary Loyzaga has urged the country's top business leaders to work with government on efforts to address the climate crisis and create sustainable communities.

Speaking at the general membership meeting of the Management Association of the Philippines (MAP) on June 14 in Taguig City, Loyzaga pointed out that "climate action for resilience is everyone's business."

"Our government partners needs who beyond **ESG** (environmental, social governance) and the fencelines of their operations to ensure ecosystem integrity and the resilience of communities that surround their operations," Loyzaga told an assembly of CEOs, COOs and other top management executives from the largest companies in the Philippines.

The environment chief added that the government also needs "partners who go beyond compliance to achieve strategic shared values, and who are committed within their core business value cycles to going beyond just their specific contributions to

MAP organization that promotes management excellence all human, social and

nation-building through the sharing of best management practices its members, among networking with other local and international business organizations, and benchmarking with counterpart organizations in other countries.

Loyzaga invited to the MAP gathering to discuss the national priorities the environment, natural resources and climate change, providing an avenue for potential partnerships collaboration between Department of Environment and Natural Resources (DENR) and the business community.

According to Loyzaga, the Marcos administration's agenda of "pursuing a green and blue economy and establishing livable and sustainable communities" guides the DENR in fulfilling its mandate of protecting the environment, managing building and resilience in all natural domains.

"Our work covers the air we breathe, all life on land and below water, and all our natural resources. In sum, our priorities are to protect, conserve, restore and regenerate the ecosystems that serve as the life support for economic development," she said.

Loyzaga also called on MAP members to "come forward and do your share" in tackling plastic pollution by committing to the full implementation of Republic Act 11898, or the Extended Producers Responsibility (EPR) of 2022. "Some of you have already stepped forward and committed to work with us," she said.

The EPR law serves as the environmental policy approach and practice that requires producers to be environmentally responsible throughout the life cycle of a product, especially its postconsumer or end-of-life

"Among the biggest threats to the environment unsustainable consumption production practices that lead to production of polluting waste. This is where our partnerships would not only strategic but critical to our survival," Loyzaga said.

"Confronting complex roots of the pollution on land, seas and air requires a whole of society effort that will come at a cost but will have far reaching benefits," she

Loyzaga said the EPR law is an opportunity to curb the destruction of ecosystems by setting targets for large enterprises to cover and divert 20 percent of the plastic waste they produce in 2022 by the end of 2023, gradually increasing this by 40 percent by 2024 and setting 10 percent targets until 80 percent can be decreased and reached by 2028 onwards.

The DENR Secretary stressed that investments are needed not just in diversion and collection, but also in research for the substitution of single use plastic.

"Unless there a product that has the same functionality and affordability as single use plastic, the demand for its use, particularly among communities that can afford no other ways to consume and store will not wane," she explained.

Loyzaga said the DENR is also looking partnerships innovations to combat water and air pollution and is setting targets for expanding its capabilities observation, monitoring and analytics.

To accelerate transition green and contribute to the country's socioeconomic development, Loyzaga said the DENR is pursuing a risk-based approach for sustaining and accelerating economic,

environmental gains; and supporting the accounting natural resources through the Natural Capital Accounting System led by the National Economic Development Authority.

The DENR, she said, has also established and continues to strengthen the National Resources Database Geospatial and is building resilient communities through risksensitive and balanced land management and the development of resources along the natural, rural, and urban transect.

At the same time, Loyzaga said the DENR and the Department of Energy have been working together to accelerate the transition to clean energy including updating old guidelines.

Loyzaga also reported

that the DENR has engaged with the private sector in co-benefits projects that include afforestation and reforestation for carbon sequestration on land through the voluntary carbon market.

"The priorities I have outlined and the volatility and complexity of our future require us to work together to achieve: coherence in all we do, convergence in what we can do together, and synergy," Loyzaga said.

"The why behind all we do is what we deliver to our country - when we work together as whole of government and as a whole of society we can then build an inclusive and sustainable Philippines, and that would be the real national dividend," she concluded. #

# DOH-Ilocos' MR-OPV SIA ends with 91% achievement rate

DAGUPAN (PIA) – The Department of Health (DOH) Ilocos successfully concluded the Measles, Rubella bivalent Oral and Poliovirus Supplemental Immunization Activity (MR-bOPV SIA) on June ng 15, 2023.

the activity resulted in a total of 91% vaccination coverage for the measlesrubella and 85% coverage in selected areas of the region.

In a statement issued on Wednesday, DOH Ilocos regional director Paula Paz Sydiongco disclosed that a total of 378,396 out of received MR vaccination and 162,687 out of the 190,603 children in priority areas received their OPV vaccine according to the unofficial quick count and from the data submitted by units (LGU) as of June 19,

She added, "With this for the oral polio vaccine accomplishment, we can safely say that we have closed the immunization gap and prevented the measles outbreak and recirculation of poliovirus in the region."

Ilocos region ranked the 416,762 target children third in the overall nationwide vaccination coverage, with CARAGA region leading the tally with 100.38% followed by the National Capital Region with 91.04%.

According to the various local government regional MR vaccination coverage, out of the 125 LGUs, 27 have below "Nagpapasalamat 80%; 34 have between 80% - 94%; and 64 have above 95%.
