As Police Regional Office 1 (PRO-1) remains steadfast on the campaign against illegal gambling, a total of 2,655 illegal gamblers were arrested in 814 police operations conducted in the Ilocos Region in 2023.

PLTCOL Benigno Sumawang, chief of the Regional Public Information Office of PRO-1, said police authorities confiscated cash amounting to P1,239,492.95 from illegal betting in the region.

Pangasinan, operations were launched in the previous year which led to the arrest of 1,328 illegal bettors

while 585 were arrested in 153 operations in La Union; 459 were seized in 118 operations in Ilocos Sur; and 283 were nabbed in 71 operations in Ilocos Norte.

Most of the suspects were caught playing card games, video karera, Cara y Cruz, and colored games.

# Over P17-M worth of illegal drugs seized in Ilocos Region in 2023

**SAN** CITY, La Union (PIA) The Police Regional Office 1 (PRO-1), together with the Philippine Drug Enforcement Agency (PDEA), confiscated illegal drugs amounting to P17,930,543.12 in the Ilocos Region in 2023.

PLTCOL Benigno Sumawang, chief of PRO-Public Information Office, said a total of 847 joint operations were conducted in the previous year which resulted in the confiscation of some 2,600.455 grams shabu, 2,020.076 grams of marijuana, and 3.6 grams

FERNANDO of marijuana kush.

Confiscated shabu has a standard value of P17,683,094; marijuana P242,409; marijuana kush is worth P5,040.

The concerted effort of the authorities to combat illegal drugs in the region led to the arrest of 956 suspects.

Further, Sumawang noted that authorities conductedhousevisitations among identified drug personalities.

"We do not launch operations right away, instead we visit then person first, let

them surrender, and later encourage them to undergo the rehabilitation program the government," Sumawang said.

As a result, there were 206 persons who used drugs (PWUDs) that voluntarily surrendered last year.

Sumawang highlighted how PWUDs who submit to rehabilitation programs of the government can be reformed and reintegrated back into communities. (Caren Grace Cabanayan-Carbonell/ PIA Region 1)

## Jeepney drivers nod to PUV modernization in Ilocos Sur

VIGAN CITY, Ilocos Sur (PIA) — Jeepney drivers in Ilocos Sur expressed their support to the Public Utility Vehicle Modernization Program (PUVMP) of the Department of Transportation (DOTr) in an interview on Tuesday, Jan. 16.

One of the traditional jeepney drivers operating in Vigan City to and from Sinait town, Alfonso, not his real name, said don't oppose modernization; we support and also want it. We are just asking for the support of the cooperatives and our government because it is going to be difficult for us to send our children to college, and to fend for our daily needs if we have to pay a huge amount monthly."

## 'LAB for ALL' caravan to serve Ilocos Sur residents

VIGAN CITY, Ilocos Sur (PIA) -- The Libreng Laboratoryo, Konsulta at Gamot Para sa Lahat (LAB for ALL) program will organize caravans in Ilocos Sur province to provide quality healthcare and social services to residents.

Dental and family planning services and the distribution of food packs will also be delivered during the LAB for ALL, according to the provincial government.

The DOH said participants may also receive free medical check-ups for pediatrics, obstetrics and gynecology, ophthalmology, and other services.



## Laoag City gov't to open animal pound for stray dogs

LAOAG CITY, Ilocos said.) Norte (PIA) – The Laoag City government-operated dog pound and veterinary clinic is expected to operate this January 2024 to hold and treat stray dogs who are also possible rabies carriers.

According to the newly assigned city veterinarian, Dr. Samantha Josephine Licuden, they are waiting for the water lines to be finished in the pound before they can operate.

From January December 2023, the city has recorded more than 2,000 cases of animal bites.

Licuden added that this year, Laoag City recorded two cases of rabies infection among residents.

"Kapag nagkaroon ng rabies ang mga aso natin it is a very fatal disease and pwede itong pumatay ng aso at tao kapag nakagat at hindi ito mabigyan ng anti-rabies vaccine agad," she said.

("If dogs catch rabies, this can be a very fatal disease and it can kill dogs and humans when bitten if anti-rabies vaccination is not given immediately," she

Early next year, the city government will also implement the rescue of stray dogs around the area to be put and treated at the animal pound which is now being finished at Barangay Camanggaan.

In an interview, Mayor Michael Marcos Keon said that the pound will be made to accommodate 70 dogs at a

Aside from the dog pound, a city-operated animal clinic will also be put up to provide checkups and to give medications and vaccines to animals and human victims of animal

"In the building, we'll have there our office and a small clinic for consultations of minor animal-related injuries through out-patient medications," the veterinarian said.

# DOH provides interpersonal communication, counseling training for BHWs in Ilocos Region

SAN FERNANDO CITY, La Union (PIA) – A total of 640 barangay health workers (BHWs) from three Department of Health (DOH) hospitals in the Ilocos Region attended an interpersonal communication counseling training in preparation for the Periodic Intensification of Routine Immunization (PIR) program of the department for 2024.

The Mariano Marcos Hospital Memorial and Medical Center in Batac, Ilocos Norte; the Ilocos Training and Regional Medical Center in San Fernando City, La Union; and the Region 1 Medical Center in Dagupan City, Pangasinan handled the training for BHWs in various provinces.

In a statement on Tuesday, DOH Ilocos

Regional Director Paula Paz Sydiongo said that the activity is intended to provide communication skills to the BHWs as health communicators and to enhance their demand generation campaign in their respective communities.

"Interpersonal communication and counseling training is an effective way to improve and ensure service delivery. And important that it is our BHWs know of various communication strategies to influence and empower individuals in the communities to make healthier choices," she stated.

"That is why we have to make our BHWs efficient communicators because the ultimate goal of this training is to use communication

strategically to improve the health and wellbeing of individuals," Sydiongco added.

Two hundred BHWs were trained in La Union, 280 in Ilocos Norte and 160 in Pangasinan.

The training consists of various lectures and workshops involving strategies in interpersonal communications, identifying problems and concerns in the community, and addressing various health situations through proper interaction and counseling methods.

The BHWs who have undergone training will facilitate demandgeneration activities in improving coverage particularly in addressing community concerns and debunking misconceptions regarding vaccines.

Last year, the DOH in the Ilocos Region also conducted capacitybuilding activities for BHWs across the region to prepare them for their new role as health education and promotion officers (HEPOs) on the ground.

They were equipped on how they would develop activities and programs for the implementation of the seven priority areas defined in DOH's Health Promotion Framework SThese seven priority areas include nutrition and physical activity, environmental health, immunization, substance use, mental vaccination health, sexual reproductive health. and violence and injury prevention at the community level. 
