IMEE: IMPROVING POWER TRANS-MISSION NOT MAHARLIKA FUND'S RO

Senator Imee Marcos remains unconvinced that investing part of the Maharlika Fund in the National Grid Corporation of the Philippines (NGCP) was the right way to solve power transmission problems nationwide.

"Why should the MIC spend money to improve the performance of the NGCP when it is regulated by the Energy Regulatory Commission (ERC)? Why should we use public funds when regulatory measures are available?" the senator asked, citing provisions in Republic Act 9136 - the Electric Power Industry Reform Act of 2001.

The NGCP itself said funding was not a problem, but Marcos questioned how the NGCP has been spending its net income.

"The problem of NGCP is not lack of cash but lack of (Pls. turn to page 5)

Inflation rate in the Ilocos Region decelerated anew in December 2023 to 2.3 percent from month-ago's 2.9 percent, due mainly to slower upticks in the food and alcoholic beverages.

In a statement Monday, Philippine Statistics Authority (PSA) Ilocos regional director Sheila de Guzman said other contributors to the slower inflation rate last December include lower housing, water, electric, gas, and other fuels index; furnishings; household equipment and routine household maintenance; health; and recreation, sport, and

culture.

Average inflation in the region for 2023 stood at 5.1 percent, lower than the national average of 6 percent and the 8.2 percent in 2022.

De Guzman said the food index in the region slowed to 5.7 percent last December from the previous month's 7.5 percent. The level a year ago is nearly (Pls. turn to page 3)

Calling for a review of the NGCP's franchise in Senate Resolution 832, Marcos said the "alarming lack of improvement" in the NGCP's power transmission capacity "automatic has caused load-dropping incidents and grid-level outages, inadequate procurement of ancillary services to prevent outages, and delays in the completion of grid projects lasting as long as seven years."

"We could have avoided the recent power outage in Panay if the Cebu-Negros-Panay Backbone Project and the Visayas-Mindanao Interconnection Project were finished on schedule. Now, billions have been spent with no ROI (return on investment) in sight," the senator said.

Marcos said th

instead of investing in the NGCP, the government should exclude unfinished projects in the computation of the private corporation's rates.

"This will incentivize the NGCP to finish projects before recouping costs," she explained.

"There should be penalties for delays," she added, citing the recent decision of the ERC to exclude ongoing projects in resetting rates of the NGCP.

Right-of-way problems and the long process of obtaining permits from local governments also contributed to the delay in the NGCP's interconnection projects.

Marcos recalled former President Rodrigo Duterte's Executive Order No. 30, which created the Energy Investment Coordinating Council (EICC) and recognized energy projects as Projects of National Significance.

VIGAN Ilocos Sur (PIA) -- The provincial government of Ilocos Sur announced on Jan. 5 that President Ferdinand Marcos Jr. has declared Feb. 2 a special (non-working) day in the province in observance of its 206th founding anniversary.

Under Proclamation No. 431, signed by Executive Secretary Lucas Bersamin on Dec. 27, the date was made a special non-working holiday in the province to allow its residents the opportunity to celebrate its foundation day.

According to the Department of Labor and Employment, employees who attend work will receive an additional 30 percent of their daily rate while those who do not attend work will not get any pay.

In the Ilocos Region, minimum wage the rates are currently set at P435 for non-agriculture establishments with 10

or more workers, and P402 for non-agriculture establishments with less than 10 workers and agriculture workers.

DPWH completes 2 infra projects in La Union

SAN CITY, La Union (PIA) -The Department of Public Works and Highways (DPWH) in the Ilocos Region recently completed two vital infrastructure projects in La Union to enhance road safety and accessibility in the province.

DPWH-La Union First District Engineer Jose Ginete, Jr. said the newly-completed projects the 192-linearwere meter concrete dike along Baroro River in Sta. Rosa village in San Juan and the 483-meter farm-to-market road linking Barangays Pao Sur and Pao Norte in this city.

Ilocos Norte capitol bldg. goes solar

LAOAG CITY – Leading the way to a green and sustainable province, the Ilocos Norte capitol building rooftop is being installed with solar panels to cut on electricity cost in the long run

With a funding of around PHP45 million from the National Electrification Administration (NEA), Ilocos Norte Electric Cooperative, Inc. (INEC) acting general manager Cipriano Martinez said installation of solar panels at the capitol started last December and is expected to be completed soon.

INEC was also tasked to put up solar panels in public hospitals and schools.

Once completed, the solar power project will have a capacity of 470 kilowatts at its peak of operation and is expected to reduce cost of electricity in the province by 40 percent since the power generated by the solar panels will be sold to INEC to boost *Adriano /PNA*)

get crafty with their to particularly tricks, on social networking sites such as Facebook, the anticybercrime unit of the Police Regional Office-1 warned the public to be vigilant and be mindful of their online activities.

Lt. Col. Greg Guerrero, assistant chief of the Anti-Cybercrime Unit of Police Regional Office I, said a wrong click on a link posted online may lead to scams.

Identity theft, extortion, and blackmail:

With this kind of deceit that seems to be the trend nowadays, Guerrero responded, "If they receive links, do not open or click those because through that, the scammers will be able to access emails, next the passwords, social media accounts, and then the bank accounts."

He explained, "When we open such links and enter our one-time passwords, scammers can quickly withdraw all the money from our account."

He explained, "When we open such links and enter scammers can quickly withdraw all the money from our account."

He also mentioned that he receives the same fraudulent messages that contain links from unknown individuals which he immediately deletes.

He explained, "Even if there are no nude pictures or sex videos [in the accounts], the scammers will say that they have those in their possession, they can easily edit photos and videos with any face, especially now that there is Artificial Intelligence. They will use it to extort money or blackmail the victims in exchange of [sexual activity]."

Special ward for war veterans opens at Region 1 Medical Center in Dagupan

DAGUPAN CITY (PIA) - A 15-bed ward reserved for war veterans was recently opened at the Region 1 Medical Center (R1MC).

The ward, named after Lt. Col. Jaime M. Arzadon was opened on January 10Defense Undersecretary for Civil, Veterans and Retiree Affairs Reynaldo Mapagu "Gusto said, nating i-widen ang coverage ng medical care para sa mga veterans. Mapagu stated, "This is the least we can do to honor their bravery, patriotism, sacrifice, and selflessness, especially for World War II veterans." He said this is the third veterans' ward in the country that is now operational. The first one is the Northern Mindanao Medical Center in

Cagayan De Oro, and the

second one is Batangas City Medical Center.

He added that a total of 24 veterans' wards are planned to be built across the country.

Southern The Philippine Medical Center in Davao City is currently under construction, while

This call was reiterated at the concluded International Conference on Connecting the Dots On Circular Economy for Sustainable Development held in Muntinlupa City, where the DENR showcased research and solutions from experts spanning countries such as the Philippines, India, South Korea, Thailand, Lao PDR, Vietnam, Malaysia, Singapore, and Ethiopia.

The circular economy transition may involve strategies like productas-a-service models, take-back programs, and innovative product design approaches, necessitating investments in technology and infrastructure.

The DENR said that even micro, small and medium-sized enterprises (MSMEs) play a significant role in driving social and environmental progress, especially considering that these enterprises dominate the business landscape in the country.

According to a 2019 data from The World Bank, around 70% of the material value of plastics is lost to the Philippine economy each year. This is equivalent to roughly a value loss of around USD 790-890 million per year.

Republic Act 11898, known as the Extended Producer Responsibility (EPR) Act of 2022, holds producers accountable for products throughout life their cycle, encouraging eco-friendly design and recycling efforts.

While not mandatory MSMEs, for the DENR encourages them to register their programs. EPR This collective effort aims to reduce waste, conserve resources, and minimize environmental impact, fostering sustainability and economic opportunities for businesses in the Philippines. ###
