## Get anti-rabies vax for animal bite, scratch -Laoag Health Office

LAOAG CITY, Ilocos Norte, Jan. 25 (PIA) - The Laoag City Health Office (CHO) is stressing the importance of immediately getting an anti-rabies vaccine for victims of animal bites and scratches, after recording its first human fatality due to rabies infection in the city this year.

The victim, a 51-yearold resident of Barangay No. 59-A, Dibua South, was bitten by his pet cat last November 2023 but did not immediately seek medical attention to treat the bite.

According to CHO, the victim passed away in the first week of January.

With this, Dr. Joseph Adaya, city health officer, is appealing to the public to avail of their free anti-rabies vaccination service if bitten or scratched by animals and only go to accredited clinics or hospitals.

## Pamulinawen Festival: Laoag City's month to shine

Ilocos Norte's capital, Laoag City, is known as the Sunshine City because Laoag or "lawag" means "light" in Ilokano.

That is why this year's Pamulinawen Festival carries the theme "Shine Laoag" – fitting for the festivities that will highlight the culture, history, and famous destinations in the city this February.

The month-long festivities will kick off on Feb. 1, with a military parade followed by the Panagyaman (Thanksgiving) Concert at the Aurora Park.

On Feb. 2, the city government will spearhead the launching of the Agro-Industrial Fair at Laoag Central **Elementary School.** 

The fair will showcase local-produced products including furniture, home decorations, plants, fresh produce, and other processed food products.

Decorated kalesas or horse-drawn carriages will also take the center stage during the Calesa Parade on February 8 in front of the Provincial Capitol.

On Feb. 9, the city will stage the awaited Pamulinawen Grand Parade and float competition contest which will be joined by barangays, government agencies and offices, business establishments, and some schools in the city.

Ilokano culture and history will also be told in the form of dance at the Na-Laoag Street Dance Parade on Feb. 10.

Ten clustered competitors composed of the city's 80 barangays will compete for the dance championship title.

To showcase the beauty and wit of the people in the city, the Miss Laoag Pamulinawen 2024 and Mister Laoag pageant on Feb. 11 and 13, respectively, will be staged.

City tourism officer Angel Lao said this year's Miss Laoag Pamulinawen will stage a pre-pageant presentation on Feb. 5.

"A Miss Pamulinawen is strong, confident, resilient, and in any adversity, they rise up. For this year's edition, we are looking for the girl who will shine the brightest and the Pamulinawen that we celebrate every year," she added.

## Mass deworming for children to roll out in Ilocos Norte

CITY, LAOAG Ilocos Norte (PIA) - The Provincial Health Office (PHO) will be conducting a mass deworming activity this month for one to four years old to reinforce the prevention and control of soil-transmitted helminths.

During the PIA Ilocandia Forum, Dr. Rickson Balalio, acting provincial health officer, said that some 6,000 toddlers will be the initial recipients of the government's drive to eliminate intestinal parasitism among children.

"Ang mass deworming natin is kino-conduct twice a year- during January and July. Ang ginagawa natin ngayon is deworming sa lahat ng ating mga kabataan," said

Balalio.

The health officer said a school-based effort to deworm kids aged 5-12 years old will also be conducted. Meanwhile, community-based а deworming activity will be held once the deworming tablets are distributed by the Department of Health (DOH).

Rickson enjoins parents to bring their children to the mass deworming activities in the province as parasitic infection brings risk in the physical and cognitive development of the child.

"Kapag may mga bulate yung mga anak natin, naaagawan po ng

nutrisyon yung bata. Mabagal ang growth and development ng bata," said Balalio.

When untreated, children with parasitic infection will develop anemia and malnutrition, which will affect school performance.

Balalio advises the public to cook their food properly and carefully before it, practice proper hygiene, and wear shoes or appropriate footwear to ensure no direct contact

with sand and soil.

"We encourage you to support the deworming activity ng DOH, PHO, ng ating local government units, at schools. Let us all support the programs of the health sector," ended Balalio.

То lessen environmental issues on waste, the head of ENRO stated that anyone can members in separating implement basic waste management in their homes. When properly segregated, households will be able to maintain cleanliness and prevent unwanted odors.

"If plastics and biodegradable products are mixed in one trash can, it would produce an unpleasant smell in your house. But when separated, it leaves no odor," said Killa.

Moreover, she also shared that when proper waste segregation is observed, it would be easier to perform different processes such

as composting, plastic recycling, and waste diversion.

To guide household different types of wastes, here are other simple tips from ENRO:

1. Keep separate trash cans for dry and wet wastes. If possible, another for papers and one for the plastics;

2. Dispose wet garbage daily;

3. Do not mix batteries and chemicals with regular wastes.

("We always remind the public, if they are bitten by any animal, they should immediately come to us for their antirabies vaccine. Don't go to healers for "tandok" because there is a bigger risk of infection in the wound," he said.)

"Tandok" is a method used by traditional healers in supposedly extracting the rabies virus from the bite wound through the use of an animal horn.

Free anti-rabies vaccination is available at the Animal Bite Center of the Laoag CHO.

Moreover, the CHO is reassuring it has enough units of anti-rabies vaccine procured by the local government of Laoag and from the Department of Health (DOH).

Currently, the CHO is not monitoring any suspected human rabies infection in the city.

If a suspected case is reported, the city government will provide interventions like contact tracing of close contacts, provide them with antirabies vaccine, and continuously monitor close contacts if they manifest infection symptoms for early detection.

"Unfortunately, when we confirm that it is rabies infection, it already cannot *Norte*)

be treated, the best we can do is refer to hospitals for proper care and conduct contact tracing to end the spread of infection," Adaya added.

To prevent the further spread of rabies in animals, the City Veterinary Office is continuously conducting anti-rabies vaccination activities for dogs and cats at the barangay level.

As of posting, the city animal pound is still not operational, according to Dr. Samantha Licudine, the city veterinarian.

"As of now we are fast-tracking the finishing, purchase of a vehicle, and employment of staff for the animal pound," she said.

However, the city veterinarian is positive that the animal pound will operate before the month ends or the following month.

She added that as of now, the animal pound has a 50-dog capacity, but additional cages will be delivered in the following weeks.

She also appealed responsible for pet ownership among residents, emphasizing the importance of getting regular anti-rabies vaccinations for pets, keeping pets inside their property, and providing proper care for animals so they don't end up as strays.

Once the animal pound is operational, the veterinary office will prioritize the capture and rescue of rabies-infected animals to mitigate infection. (Emma Joyce Guillermo/PIA Ilocos

#### PROVINCIAL ORDINANCE NO. 059-2023

#### AN ORDINANCE FURTHER AMENDING PROVINCIAL TAX ORDINANCE NO. 2020-001 (AS AMENDED) OTHERWISE KNOWN AS THE REVISED **REVENUE CODE OF 2020 OF THE PROVINCE OF ILOCOS NORTE AND** FOR OTHER PURPOSES.

WHEREAS, the Constitution mandates that the State shall protect and promote the right to health of the people and to instill health consciousness among them;

WHEREAS, the Local Government Code of 1991 empowers every local government unit to exercise the powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of general welfare, health and safety including the provision of services to control communicable diseases;

WHEREAS, the Provincial Government of Ilocos Norte has recently acquired new medical machinery and equipment for the Gov. Roque B. Ablan Sr. Memorial Hospital, in order to upgrade its services and uplift the health and living of the citizenry;

WHEREAS, the Provincial Government of Ilocos Norte has also caused the expansion of the said hospital with the construction of a new Diagnostic building;

WHEREAS, there is also a need to update the reading fee rates for the radiology services, which include the use of the ultrasound, CT scan and MRI, in order to keep the hospital abreast with other government hospitals;

WHEREAS, there have been new developmental activities in the Province that entail the use of various equipment and machineries which necessitate the incorporation to the government developmental fees;

WHEREAS, the amendment of Provincial Tax Ordinance No. 2020-001, as amended, becomes imperative to provide for the service fees and charges for the new hospital equipment and machinery, as well as the lease rental rate for the unoccupied portions of the Diagnostic building;

#### **NOW, THEREFORE**, Be it Ordained, that:

Section 1. Filing Fee as provided in Section 54 is hereby amended by way of addendum as follows:

Filing Fee (CSAG)	- P121.00/hectare
Filing Fee (ISAG)	- P605.00/hectare

Section 2. The provisions of Section 58 relevant to the registration of Lease Contracts/Agreements, is hereby amended, in order to harmonize with Section 63, as follows:

"SECTION 58: REGISTRATION OF ALL LEASE CONTRACTS/ AGREEMENTS OF QUARRY EQUIPMENT AND MACHINERIES - The Provincial Quarry Office shall require the registration of all Lease Contracts/Agreements entered into between the permittee and any interested party/ies in connection with quarrying equipment and machineries. He/she shall be required to pay a registration fee of One Thousand Pesos (Php1,000.00) for such Lease Contract/Agreement."



The Bagong Pilipinas campaign "calls for deep and fundamental transformations in all sectors of society and government, and fosters the State's commitment towards the attainment of comprehensive policy reforms and full economic recovery," Memorandum Circular No. 24 stated.

Secretary Labor Bienvenido E. Laguesma highlighted that proof of the Department's commitment to the campaign is the issuance of its roadmap, the Philippine Labor and Employment Plan (PLEP) 2023-2028.

The Department's priorities, target outcomes, and strategies focus on the PLEP's three key areas: employment promoting human and resource development, workers protection and welfare, and labor relations.

contributing Further to the Bagong Pilipinas governance brand of the Department's are accomplishments in the particularly past year, promoting in gainful employment and human resource development, protecting and advancing workers' rights and welfare, and maintaining sound labor-management relations and industrial peace.

#### Employment and human resource development

In 2023, the DOLE approximately assisted 181,126 youth in gaining work experience through the Special Program for Employment Students,

JobStart Program, and Philippines Program.

To address job-skills mismatch, the Department likewise provided over million individuals 4.9 with timely and relevant information on future labor market conditions through IEC materials on labor market information.

Furthermore, over 2.4 million qualified applicants were employed through the facilitation of Public Employment Service Offices, which translates to a 92 percent placement rate across the regions.

In terms of training and apprenticeship, more than 1.6 million individuals were enrolled in various technicalvocational education and training programs, and over 1.3 million of them graduated from their respective programs.

Meanwhile, approximately 1 million skilled workers underwent assessment, and 952,816 of them were certified after meeting the defined competency standards.

Regulation Commission, 85 licensure examinations were conducted during the year, with more than 301,000 passers out of the 596,999 examinees.

#### Workers' rights and welfare

Department The highlighted that in the past year, the Regional Tripartite Wages and Productivity Boards issued wage orders granting minimum wage hikes for private-sector workers in 15 regions and domestic workers in 12 regions.

In terms of labor inspection, approximately 36,638 establishments were inspected covering more than 2.8 million workers nationwide.

DOLE likewise conducted Technical Advisory Visits (TAV) to approximately 132,567 micro establishments, or those employing less than 10 workers, to guide them in complying with general labor standards and occupational safety and health (OSH) standards.

establishments are provided with labor education services and assisted by the labor inspectors or assistant labor inspectors in completing a visit checklist and identifying their compliance gaps. From there, they formulate their proposed corrections and needed technical assistance. In terms of promoting

compliance with OSH standards, the Department said that 54,585 workers were trained in various courses, such as Basic OSH, Construction Safety Training, etc.

To promote labor and enterprise productivity, the DOLE said over 19,581 micro, small, and medium enterprises availed of its orientation and training services on productivity of which 29,346 employers and workers participated.

The Department has enhanced likewise its assistance to vulnerable workers in the past year through its livelihood and employment emergency programs.

million beneficiaries were provided emergency employment through the Tulong Panghanapbuhay sa Ating Disadvantaged Workers Program, while over 153,000 workers were provided livelihood assistance under the DOLE Integrated Livelihood Program or Kabuhayan Program.

Secretary Laguesma said that contributing to the enhanced implementation of the programs were the streamlined requirements and process of availing, inclusivity in targeting beneficiaries, and the expanded package of assistance.

In support of the "Kadiwa ng Pangulo," the Department led the "Kadiwa ng Pangulo para sa Manggagawa" last year to bring affordable and quality products closer to workers.

During the Labor Day celebration, the DOLEled activity generated sales of over P6.4 million nationwide.

## Protection of rights, welfare of kasambahays a priority of gov't, DOLE

The Department of Labor and Employment (DOLE) assured domestic workers or kasambahays of the government's continued commitment to protecting their rights and welfare as the nation observed the 2024 Araw ng mga Kasambahay this January 18.

In his opening remarks at the event's culmination the Occupational at Safety and Health Center (OSHC) in Quezon City, DOLE Workers' Welfare and Protection Cluster Undersecretary Benjo Santos M. Benavidez said year's celebration this centers on bringing government services closer to kasambahays.

"Lahat po ng serbisyo ng pamahalaan, lahat po ng taong gobyerno ay nakatutok na pangalagaan o proteksiyunan ang karapatan ng mga manggagawa, katulad po ng mga kasambahay," he said.

"Handa po ang pamahalaan na ibigay nang buong-buo ang serbisyo para po sa lahat ng mamamayang Pilipino, lalong-lalo na sa sektor na gaya po ng ating mga kasambahay," he added.

Citing a 2019 survey, Undersecretary Benavidez noted that only around a million of the 1.4 million kasambahays "are without arrangement" with only 3 percent to 4 percent having written contracts and around 60 percent aware of the "Batas Kasambahay".

Republic Act No. 10361, or the "Batas Kasambahay", was signed on 18 January 2013 as part of the state's further commitment to protecting domestic workers by ensuring their safe and healthful working conditions.

"Malayong-malayo na po ang ating narating from 2013, pero malayo pa po ang kailangan nating marating... That is the very purpose why, for the celebration of the Araw ng Kasambahay this year, we mobilized lahat ng serbisyo ng pamahalaan," he said.

The official mentioned the need to expand the coverage of social security benefits, as well as the registration of kasambahays in their barangays as required by the law to protect them further.

"Sa ilalim ро ng liderato ng ating Pangulong Bongbong Marcos, sa ilalim po Pilipinas, ng Bagong dapat walang maiiwan, lalong-lalo na ang ating mga kasambahay kasi tayong lahat ay bahagi po ng iisang lipunan," Undersecretary Benavidez said.

'Para Kay K'

As the priority sector of law, at least 45 domestic workers participated in the DOLE event and received free government hands-on skills training sessions and social security services from different government offices.

In coordination with the Technical Education and Skills Development face-to-face Authority, training sessions on haircutting and massage #ParaSaFutureNiK were also conducted. Participants were also oriented on the flagship programs of the Labor Department, particularly the DOLE Integrated Livelihood Program.

During the #SerbisyoParaKayK segment of the program, guest kasambahays were given access to registration and information centers of PhilHealth, the Social Security System, Pag-IBIG Fund, the Philippine National Police, the National Bureau of Investigation, and the Department of Social Welfare and Development.

The National Conciliation and Mediation Board also offered legal services while the Bureau of Working Conditions and OSHC provided medical services to participating kasambahays. Pamphlets stating the basic information on the "Batas Kasambahay" and the rights of domestic workers distributed were also during the program.

Children of the kasambahays were also given school supplies and other goods donated by the Federation of Filipino Chinese Chambers of Commerce & Industry, Inc. They were also entertained by a child-friendly film through the help of the National Council for Television, Children's along with a puppet show by the Philippine Information Agency.

This year's Araw ng mga Kasambahay observance was organized by the Bureau of Workers with Special Concerns (BWSC) in line with the 11th anniversary of the legislation. Service caravans will also be held in other regional offices of the DOLE across the country.

Assistant Secretary Dominique Rubia-Tutay thanked the Sentro ng mga Nagkakaisa Progresibong at United Manggagawa, Domestic Workers of the Philippines, and other stakeholders for joining the event.

"Mas marami pa [sana] tayong mahikayat na mga kasama para maging mas malakas ang boses natin, lalong-lalo na kung ang pag-uusapan natin ay polisiya para sa ating mga karapatan, para sa ating kaunlaran," she said. AG#

Based on statistics, PRO-1 noted downward trends in most of the eight focus crimes in the previous year compared to the cases recorded in 2022.

Cases of theft in 2023 decreased to 268 from 312 in 2022; robbery declined to 89 from 108; physical injuries alleviated to 153 from 229; homicide was down to 37 from 48; and rape cases dipped to 401 from 427.


